ORDER:

The Mission Director, State Health Society has stated that in Government Orders 1st, 2nd, and 3rd read above among others, a total number of 147 Urban Primary Health Centres have been established in the respective municipalities. In the Government order 4th read above, a total no of 10 Urban Primary Health Centres out of 147 sanctioned have been cancelled. In the Government Order 5th read above, necessary amendment has been issued to transfer the three Urban Primary Health Centres from control of the Director of Public Health and Preventive Medicine to Chennai Corporation. In Government Order 7th read above among others 280 Urban Primary Health Centres have been established including the 243 existing facilities under the control of Urban Local Bodies and Director of Public Health and Preventive Medicine and 37 New Urban Primary Health Centers and also sanctioned required posts of staff nurses for providing 24 X 7 Care Services on par with Rural Primary Health Centres in the State.

2. The Mission Director, State Health Society has now stated that as on date, only 56 Urban Primary Health Centers, with less than 50,000 population, are now functioning under National Rural Health Mission, as non 24x7 Care Services Centres, after the classification based on the population and re-distribution of Urban and Rural Primary Health Centres. The approval issued Record of Proceedings 2014-15 is continued every year and proposal in Programme Implementation Plan 2018-19. In order to extend to 24x7 Care Services to 56 Urban Primary Health Centres under National Rural Health Mission, the Director of Public Health and Preventive Medicine, Chennai has requested for sanction of 56 posts of Staff Nurses in regular time scale of pay and 112 posts of Staff Nurses on contractual basis, as per the guidelines issued in G.O(Ms)No.400, Health and Family Welfare (AA-1) Department, dated 16.12.2014 and that in the Government Order 7th read above, 280 Urban Primary Health Centers with population of more than 50,000 had been sanctioned required posts of staff Nurse for providing 24x7 Care Services through them. Therefore, 56 Urban Primary Health Centers under National Rural Health Mission with less then 50,000 population may be sanctioned 168 posts of staff nurses in order to provide 24x7 care services in these Urban Primary Health Centers as per the approval issued by Government of India.

3. The Mission Director, National Health Mission has further stated that in 56 Staff Nurses to be posted in regular pay levels to the Urban Primary Health Centers under 24 X 7 Scheme, the salary in regular pay level may be drawn from State funds through treasury and staff cost may be reimbursed to Government by remitting the funds approved Government of India, as contractual pay for these posts, as in the case various posts sanctioned to Primary Health Centers and Upgraded Primary Health Centers under National Rural Health Mission. The funds for staff cost for 112 contractual Staff Nurses may be released to the concerned District Health Societies, as being done in the case other 24 X7 Primary Health Centers.

4. The Mission Director, State Health Society has therefore requested the Government to issue necessary orders for extending "24 X 7 care services" to the 56 Urban Primary Health Centers which enlisted in the Annexure and to sanction the required staff Nurses post in this regard.

5. The Government after careful examination of the proposal of the Mission Director, State Health Society / National Health Mission have decided to accept it and accordingly issue the following orders:

- i. Sanction is accorded for creation of 56 posts of Staff Nurse in regular pay levels (Regular time scale- Level-14, Rs.36000-114000) and 112 posts of Staff Nurse on contractual basis (2:1) (On Contract pay @ Rs.14000/-pm with annual increment of Rs.500/-only) as per the directions issued in GO.Ms.No.400, Health and Family Welfare (AA I) department, dated: 16.12.2014 to provide 24x7 care services in the 56 Urban Primary Health Centers which enlisted in the annexure to this order at three posts per Primary Health Center.
- ii. The 56 post of regular Staff Nurse will be placed under the administrative Control of Director of Public Health and Preventive Medicine and filled up through Medical Recruitment Board and cadre controlling authority is Director of Medical and Rural Health Services. The 112 Contract Nurses be filled up through MRB, as Per National Health Mission norms.
- iii. The Director of Public Health and Preventive Medicine, Chennai is permitted to draw and disburse the salaries for 56 posts of Staff Nurse in regular pay levels through the concerned Drawing Officers by treasury mode.
- iv. The Mission Director, National Health Mission is permitted to remit the staff cost in respect of 56 posts of staff nurses in regular pay levels into Government of Tamil Nadu Account.
- v. The salary for the Contract Staff Nurse posts will be paid by National Health Mission/ State Health Society, Tamil Nadu from the funds approved under National Rural Health Mission through respective District Health Society. The Mission Director, National Health Mission is permitted to release salary cost for Staff Nurse on contract basis to the respective District Health Society.

6. The amount sanctioned in respect of Staff Nurse in regular pay in para 5 (i) shall be debited under the following Head of Account.

8. The expenditure sanctioned in para-5(i) above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Director of Public Health and Preventive Medicine is directed to apply for sanction of advance from the Contingency Fund to Finance (BG.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. The Director of Public Health and Preventive Medicine is requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2019-2020 to Finance (BG.I/ Health.I) Department without fail.
