ORDER:-

In Government Order first read above, sanction has been accorded for creation of 8 (Eight) supernumerary posts (2 seats for The Tamil Nadu Dr.M.G.R. Medical University and 6 seats for ESI, PGIMSR) in the Kilpauk Medical College Hospital, Chennai for the Medical Officers undergoing Post Graduate Course in the Quasi Government Institutions / Government of India Institutions for the purpose of claiming salary.

2. The Director of Medical Education in her letter second read above has stated that the salary for the candidates who have joined the course in previous years and who are in the 2nd or 3rd year are currently being claimed in the above 8 supernumerary posts. For the academic year 2013-14, 6 service candidates have allotted and joined the Post Graduate Course in the Quasi Government Institutions/ Government of India Institutions. She has also informed that the Registrar, The Tamil Nadu Dr.M.G.R. Medical University has stated that the Medical Council of India has granted permission for increase of seats from 2 (two) to 3(three) for the Post Graduate Course in M.D.(Immuno-Haematology and Blood Transfusion) from the academic year 2013-14 and as per the permission granted by the Medical Council of India, the Selection Committee, allotted 3 candidates for the academic year 2013-14 and they have joined the Post Graduate Course in M.D.(Immuno-Haematology and Blood Transfusion) in the Tamil Nadu Dr. M.G.R. Medical For the academic year 2013-14, three service candidates have been University. allotted to ESI, PGIMSR, out of the 3, two service candidates have been allotted to

- do M.S. (Obstetrics & Gynaecology), and one service candidate has been allotted to do M.D. (Paediatrics). The salary for all the 6 service candidates is to be borne by the Government as being done to their seniors (service candidates) who were admitted in the academic years 2011-12 and 2012-13. Every year there are chances for increase of seats in the Post Graduate Course in Quasi Government Institutions / Government of India Institutions and the service candidates who are allotted seats in the said Institutions may vary every year. Moreover, the year of completion of Post Graduate Course of the service candidates may also vary depending upon their qualification already acquired by them. She has, therefore, requested the Government to increase the sanctioned strength of supernumerary posts from 8 to 12 to claim the salary for the service candidates undergoing the above courses for the year 2013-14.
- 3. The Government have examined the proposal of the Director of Medical Education in para 2 above. At present only 8 supernumerary posts have been created for the purpose of claiming salary to the service candidate pursuing Post Graduate course in the above Quasi Government institutions / Government of India Institutions. 12 service candidates are pursuing Post Graduate Course (3rd year 4 candidates, 2nd year 2 candidates and 1st year 6 candidates) (ie) in The Tamil Nadu Dr. M.G.R. Medical University (6 candidates) and ESI,PGIMSR (6 candidates). Hence it is, necessary to increase the sanctioned strength of supernumerary posts from 8 to 12 to claim the salary for the service candidates undergoing the above courses for the year 2013-14.
- 4. The Government have therefore decided to accept the proposal of the Director of Medical Education. Accordingly, sanction is accorded to increase the sanctioned strength of supernumerary posts at Kilpauk Medical College Hospital, Chennai from 8 to 12 for the purpose of claiming salary for the Medical Officers undergoing Post Graduate Course (2013-2014) in the Quasi Government Institutions / Government of India Institutions i.e. [The Tamil Nadu Dr.M.G.R. Medical University (6 seats) and ESI, PGIMSR (6 seats)].
- 5. This order issues with the concurrence of Finance Department vide its U.O.No.50510/H-II/2014, dated:18.11.2014.
