#### **ORDER:**

The Mission Director, State Health Society in his letter fourth read above has informed that Government of India Central funds under the Centrally Sponsored Schemes like National Health Mission are routed through the Treasury route as part of the State Plan and requested to provide for central share of National Health Mission in the State Budget for 2014-15.

2. The Government of India In the letter dated 26.06.2014 has transferred and credited a sum of Rs.3,00,00,000.00/- into State Government account as its 75% of Grants in Aid for the financial year 2014-15. Government of India has requested to ensure that 25% of State Share based on the release of funds by Government of India have to be credited into appropriate accounts.

3. The Mission Director, State Health Society has also stated that based on the 75% of the Government of India share amount of Rs. 3,00,00,000.00 (Rupees Three

Crores Only) credited in to State Government Account, the corresponding 25% of the State Share on the total funds released by Government of India works out to Rs. 1,00,00,000/- (Rupees One Crore Only). Total Amount of release under National Programme for Control of Blindness for 2014-15, ie., share between Centre and State is Rs.4,00,00,000/-(Rupees Four Crores Only) .

4. The Mission Director, State Health Society has requested that in order to implement the schemes under above said programme during 2014-15, he has requested the Government to issue orders for the release of Government of India funds as well as the State Share so as to enable to draw the funds through treasury mode. He has requested to authorized the Mission Director, State Health Society and Project Director Reproductive and Child Health Project, Tamil Nadu, to draw a sum of Rs. 4,00,00,000/- (Rupees Four Crores Only).

5. The Government, after careful consideration have decided to accept the request of the Mission Director, State Health Society and they accordingly sanction a sum of Rs.4,00,00,000.00/- (Rupees Four Crore Only) i.e., Rs.3,00,00,000.00/- (Rupees Three Crores Only) being 75% Central Grants in Aid and a sum of Rs.1,00,00,000.00/- (Rupees One Crore Only) being 25% of State Share of National Health Mission as matching grants to the State Health Society, Tamil Nadu for Procurement of Ophthalmic Equipments under National Programme for Control of Blindness for the year 2014-15.
