

ABSTRACT

Implementation of Occupational Health Services for Unorganized (Informal) sector workers in all 32 districts of Tamil Nadu with the existing Mobile Medical Units – Permission – Accorded - Orders - Issued.

ORDER:

In the Government Order first read above, the Government of Tamil Nadu have issued orders for constitution of State Level Co-ordination Committee, State Level Technical Committee and District Level Co-ordination Committee for prevention and control of Silicosis.

- 2. In the Government Order second read above, the Government of Tamil Nadu have issued orders for creation of an 'Occupational, Social and Environmental Health Wing' in the Directorate of Medical and Rural Health Services, Chennai with an objective to oversee activities relating to the screening and management of occupational and environmental diseases in the secondary care institutions under Directorate of Medical and Rural Health Services.
- 3. In the letter third read above, the Mission Director, National Health Mission has stated that, the orders issued in Government Order first read above is restricted to prevention and management of only one occupational disease i.e., silicosis while several other occupational diseases still remain unattended. Further, the mandate of Government Order second read above is restricted to secondary care hospitals only, primary care and tertiary care institutions under Directorate of Public Health and Preventive Medicine and Directorate of Medical Education are not included. A public health intervention/ program has to be implemented at all 'levels of care' namely, primary, secondary and tertiary care levels so as to make it complete and full-fledged. Restricting a public health program like occupational health to secondary care institutions alone would not yield overall desired outcomes. To ensure coordinated inter-sectoral action to address the issues of occupational and environmental health determinants and strengthen the health system of the State, National Health Mission, Tamil Nadu had conducted a consultative meeting and after due deliberations, decided to integrate Occupational Health Services into the existing health system. The proposed strategy for establishment of Occupational Health Services in the State is mentioned below:-
 - (i) Occupational health will be treated as a 'Public Health priority' and will be integrated into the existing health system utilizing existing resources including Human Resources.

- (ii) National health Mission to provide additional financial support for occupational health Services and converge with other Government departments whenever necessary.
- (iii) Expanding the scope of G.O (Ms) No. 219, Health and Family Welfare (P1) Department, dated: 11.07.2012 from Silicosis to several other occupational and work-related diseases.
- (iv) Expanding the scope of G.O (Ms) No. 171, Health and Family Welfare (F) Department, dated 10.05.2017 from Secondary care institutions of Directorate of Medical and Rural Health Services to Primary Health Care and Tertiary health care facilities of Directorate of Public Health and Preventive Medicine and Directorate of Medical Education respectively.
- (v) All Mobile Medical Units, on Saturdays of every week and on one working day in the first week of the month, should be utilised for conducting camps in areas where unorganised sector people are working like Quarries, Brick klins, Rice Mill, Fisher men areas not covered in regular FTP of Mobile Medical Unit, Salt pan areas, Palm product workers, construction sites, sanitary workers etc.
- (vi) To establish Occupational Health Clinical Services through Directorate of Medical Education with the medical specialties of Thoracic Medicine / General Medicine, ENT, Dermatology, Opthalmology and Orthopedics in all 22 Medical College Hospitals and through Directorate of Medical and Rural Health Services in 13 District Head Quarters Hospitals in non-medical college districts utilizing the existing resources including human resources. These would be the Referral Units.
- (vii) The Deputy Directors Health Services of 42 HUDs are responsible for ensuring implementation, supervision and monitoring of outreach occupational health services including health education, screening and follow-up services through Mobile Medical Units.
- (viii)Since most of the Occupational Health illnesses are related to Respiratory and Skin issues, The Deputy Director (TB) and Deputy Director (Leprosy) will make their respective contribution to Occupational Health Services Program in their respective districts through timely identification, referral and follow up. The Deputy Director (TB) under Directorate of Medical and Rural Health services would facilitate referral of occupationally induced respiratory diseases. *Likewise, the Deputy Director (Leprosy) under Directorate of Public Health and Preventive Medicine will also facilitate referral of occupationally induced skin disorders.
- (ix) School Health teams will include screening camps for early identification and referral in Government aided schools located nearby Quarry areas, Brick Kilns, Blue Metal quarries, Cement factories and other dust prone and industrial polluting areas as per local situation as school children in such areas are at risk and prone to occupational health hazards
- (x) The District Program Officer (NCD) to coordinate with institutions under Director of Public Health and Preventive Medicine, Director of Medical and Rural Health Services and Director of Medical Education for effective delivery of occupational health services.
- (xi) Converge with Department of Labour and Department of Geology and Mining for effective implementation.
- 4. The Mission Director, State Health Society has also stated that, in order to deliver specialized Occupational Health services through Mobile Medical Units, it is necessary to provide special equipment. Hence a detailed proposal was included in Programme Implementation Plan 2019-20 for providing funds for equipment, printing of screening tool questionnaire and IEC. The Government of India in Record of Proceedings 2019-20 has approved Rs 48 lakhs for strengthening 64 Mobile Medical Units of 64 blocks identified by concerned Deputy Director of Health Services in 32 districts to provide occupational health services.

The equipment will be currently supplied for 64 Mobile Medical Units covering 32 districts @ 2 Mobile Medical Unit per district as a pilot project, and in a phased manner, similar necessary equipment will be provided for screening through all other balance Mobile Medical Units in the state in future. Further, the Mission Director, State Health Society has stated that, the above proposal have been placed and approved in 37th Executive Committee meeting held on 11.2.2019.

- 5. The Mission Director, National Health Mission has therefore requested the Government to issue necessary orders in this regard.
- 6. The Government have examined the proposal of the Mission Director, National Health Mission and have decided to accept it. Accordingly, the Government issue the following orders:-
 - (i) Permission is accorded to the Mission Director, National Health Mission for planning, coordinating, financing, monitoring and evaluation of Occupational Health Services for unorganized sectors in the State, at various levels as follows:-

(ii) The Mission Director, National Health Mission is also permitted to integrate Occupational Health Services in TB elimination and Leprosy eradication programs for early identification, referral and follow up and to converge with Department of Labour and Department of Geology and Mining for effective implementation of Occupational Health services.

(iii) Permission is accorded to the Director of Public Health and Preventive Medicine as

follows:-

a) To conduct outreach Occupational health services for unorganized sector workers through all Mobile Medical Units, on Saturdays of every week and on one working day in the 1st week of the month for unorganized sector workers.

b) To integrate outreach camps near schools through existing RBSK team in dust prone areas for early identification and timely referral as a part of School Health

Program.

(iv) Permission is accorded to the Director of Medical and Rural Health Services to establish 'Occupational Health Clinic' in 13 District Head Quarter Hospitals of Ariyalur, Cuddalore, Dindigul, Erode, Krishnagiri, Namakkal, Nagapattinam, Ramnad, Tiruvallur, Tiruppur, Perambalur, Virudunagar, Nilgiris utilizing the existing resources under the coordination of General Physician/ Chest Physician.

(v) Permission is accorded to the Director of Medical Education to establish 'Occupational health clinic' in 22 Medical College Hospitals viz., Rajiv Gandhi Government General Hospital Chennai, Kilpauk, Stanley, Omandurar, Thanjavur, Vellore, Villupuram,

Dharmapuri, Kanchipuram (Chengalpet), Kannyakumari, Karur, Pudukkottai, Sivagangai, Theni, Thiruvarur, Thoothukudi, Thiruvannamalai, Coimbatore, Madurai, Salem, Trichy, Tirunelveli utilizing existing resources in coordination with Thoracic Medicine Department.
