ORDER:

The Mission Director, State Health Society in his letter third read above has informed that the funds under the Centrally sponsored Schemes like National Health Mission are routed through the Treasury route as part of the State Plan and requested to provide for central share of National Health Mission in the State Budget.

2. The Government of India in their letter dated 26.06.2014 transferred and credited a sum of Rs.41,93,000/- into State Government account as its 75% of Grants in Aid for the financial year 2014-15: under National Leprosy Eradication Programme. Government of India has requested to ensure that 25% of its share based on the release of funds by Government of India is credited into appropriate accounts.

3. The Mission Director, State Health Society has also stated that based on the 75% of the Government of India share amount of Rs.41,93,000.00 (Rupees Forty One Lakh ninety three thousand only) credited in to State Government Account , the corresponding 25% of the State Share on the total funds released by Government of India works out to Rs.13,97,667/- (Rupees Thirteen lakh Ninety Seven Thousand Six

Hundred and Sixty Seven Only). Total amount of release under National Leprosy Eradication Programme for 2014-15 i.e., share between Central and State is Rs.55,90,667/- (Rupees fifty five lakh ninety thousand six hundred and sixty seven only). Since, Government of India has transferred the grants to State Government for drawal of amount through Treasury route from 2014-15. The Mission Director has requested the Government of Tamil Nadu to release First Installment of Grant-in-aid amounting Rs.55,90,667/- to Rs.41,93,000/- as 75% of Government of India share and 25% of State share of Rs.13,97,667 to the State Health Society, Tamil Nadu State under National Rural Health Mission for National Leprosy Eradication Programme for the financial year 2014-2015.

4 .The Mission Director has requested that order to implement the schemes under above said programmes during 2014-15, he has requested the Government, to issue orders for the release of Government of India funds as well as the State share so as to enable to draw the funds through treasury mode and to draw a sum of Rs.55,90,667/- (Rupees fifty five lakhs ninety thousand six hundred and sixty seven only).

5.The Government after careful consideration have decided to accept the above proposals of the Mission Director, State Health Society and they accordingly sanction a sum of Rs.55,90,667(Rupees Fifty Five Lakhs and Ninety Thousand and Six Hundred and Sixty Seven Only) i.e., Rs.41,93,000 (Rupees Fourty One Lakhs and Ninety Three Thousand Only) being 75% Central grant in Aid of and a sum of Rs. 13,97,667 being 25% of State Share as Matching grant to the State Health Society, Tamil Nadu to implement the schemes under National Leprosy Eradication Programme during 2014-15.

6. The amount sanctioned in para 4 above shall be debited to the following head of account:
