### ORDER:-

In the Government order second read above, orders were issued to avail tie-up facilities with Government Medical College & ESIC Hospital, Singanallur, Coimbatore for the clinical training in respect of 3<sup>rd</sup> year BDS Students (with 100 admission) of RVS Dental College and Hospital, Coimbatore to undergo training for a period of three years from the academic year 2015-2016 to 2017-2018.

2. In his letter third read above, the Principal, RVS Dental College and Hospital, Coimbatore has requested further extension of tie-up facilities to avail facilities with Government Medical Colleges & ESIC Hospital, Singanallur, Coimbatore for their clinical training in General Medicine & General Surgery in respect of 3<sup>rd</sup> year BDS Students (with 100 admission) for a period of three years from the academic year 2018-2019 to 2020-2021. In this regard, the Director of Medical Education has requested to issue orders for extension of tie-up facilities.

The Government, after careful examination, on the recommendation of the Director of Medical Education, have decided to accept the same and permission to granted the Principal, RVS Dental College and Hospital, Coimbatore, to avail the tie-up facilities with Government Medical Colleges & ESIC Hospital, Singanallur, Coimbatore for their clinical training in General Medicine & General Surgery for their BDS Students (with 100 admission) for a period of three years from the academic year 2018-2019 to 2020-2021, subject to the following conditions:-

- i) The field visit should not be detrimental to the normal functioning of the hospital.
- ii) The students should be deputed in small batches;
- iii) The Institution should pay the fees prescribed as per G.O (D) No.1258, Health and Family Welfare Department, Dated: 20.11.2014, i.e., Rs.10,000/- per student per annum.
