ORDER:

The Mission Director, State Health Society in his letter read above has stated that the State Health Society is releasing funds to Tamil Nadu Medical Service Corporation to procure and supply equipments required to various departments of Medical Institutions. At present the specification required for the equipments are received from the indenting department and sent to Tamil Nadu Medical Service Corporation. After floating tender, many bidders have raised clarification on the published technical specification stating that the specification is company specific and it is not a generic one and hence need amendments.

The Mission Director, State Health Society has also stated that it is necessary to constitute a technical expert committee to finalise the specification and to evaluate the technical bids at Tamil Nadu Medical Service Corporation comprising of minimum two specialists from the department concerned.
