The corresponding 40% of the State share against the 60% of the Government of India share of Rs.117,59,00,000/- (Rupees One Hundred and Seventeen Crore and Fifty Nine Lakh only) works out of Rs.78,39,33,333/- (Rupees Seventy Eight Crore Thirty Nine Lakh Thirty Three Thousand Three Hundred and Thirty Three only).

- 2. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.195,98,33,333/- (Rupees One hundred and Ninety Five Crore Ninety Eight Lakh Thirty Three Thousand Three Hundred and Thirty Three only) towards the State share (Rs.78,39,33,333/-) and Central share (Rs.117,59,00,000/-) of Grants-in-Aid to the Reproductive Child Health Flexible Pool including other programme and Comprehensive Primary Health Care under HSS during 2019-20 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit into National Health Mission Account.
- 3. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.195,98,33,333/- (Rupees One hundred and Ninety Five Crore Ninety Eight Lakh Thirty Three Thousand Three Hundred and Thirty Three only) being the State (Rs.78,39,33,333/-) and Central Share (Rs.117,59,00,000/-) contribution of Grants-in-Aid to the Reproductive Child Health Flexible Pool including other programme and Comprehensive Primary Health care under HSS for the year 2019 2020.
