Pending approval of legislature, the expenditure will be initially met by an advance from the Contingency Fund orders regarding which will be issued by Finance (BG-I) Department. The Director of Medical Education is directed to send an application in the prescribed form along with copy of this order to Finance (BG.I) Department for sanctioning the advance for required quantum. The Director of Medical Education is also directed to send necessary note for inclusion of the expenditure in the Supplementary Estimate for the year 2014-15 to obtain approval of the legislature at the appropriate stage.
