## ORDER

In the Government order first read above, orders were issued for transferring of the Government Hospital, Saidapet, Chennai functioned under the administrative control of Directorate of Medical Education to the administrative control of the Directorate of Medical and Rural Health Services.

2. The Director of Medical and Rural Health Services his letter second read above has stated that the above said Government Hospital, Saidapet, Chennai is now functioning as Government Taluk Hospital, Saidapet Chennai in the jurisdiction of the Kancheepuram district Joint Director of Health Services under this Directorate control. At present, the said Government Taluk Hospital, Saidapet Chennai is functioning with 36 beds with the attendance of average of 982 Out Patients per day and 8 numbers of Inpatients per day and facilitate the facility of Lab, X-ray, ECG and USG to the public in and around the said area. Apart from the above, X-ray building at a cost of Rs.50 lakhs with 300 MA Computerized Radiography is also functioning in the said hospital. The necessary Manpower has been sanctioned to the Government Taluk Hospital, Saidapet Chennai. The supervision and monitoring of health activities in day to day administration leads to more difficulties to the Joint Director of Health Services, Kancheepuram, since the said Government Hospital, Saidapet, Chennai is located in the middle of the Greater Chennai limit. Except the above said hospital, no kind of Secondary Care hospitals is functioning

under the administrative control of this Directorate in the Greater Chennai limit and all the Government Medical Teaching Institutions, inclusive of Government Peripheral Hospital, KK Nagar, Anna nagar and Periyar nagar are located in the Greater Chennai limit and functioning under the administrative control of the Directorate of Medical Education, Chennai-10. All the Joint Director of Health Services in the State of Tamil Nadu are facing more difficulties in procurement of adequate Oxygen supply/medical treatment and etc., related to COVID-19 pandemic situation at present and especially the same kind of difficulties are being additionally added to the Joint Director of Health Services, Kancheepuram, since the said Government Hospital, Saidapet is located in the middle of the Greater Chennai limit and functioning under the jurisdiction of the Joint Director of Health Services, Kancheepuram District. On considering the pandemic situation at present in the Greater Chennai and also with the raise of affected COVID patients in this situation and since located in the middle of Greater Chennai and to ease the supervision and monitoring of health activities in day to day administration, since the exclusive COVID Hospital is functioning in the King Institute at Guindy, Chennai which is very near to the Government Taluk Hospital, Saidapet and also considering the process of effective action for the accommodation of 130 beds exclusive for the treatment of COVID patients very shortly.

3. The Director of Medical and Rural Health Services has furnished the suggestion that said Government Taluk Hospital, Saidapet, Chennai may be attached to the control of Government Royapettah Hospital, Chennai functioning under the administrative control of Directorate of Medical Education, Chennai-10 as the functioning of existing Government Peripheral Hospital, KK Nagar, Anna Nagar and Periyar Nagar.

4. The Director of Medical Education has also accepted the above requisition for transfer of the Government Taluk Hospital functioning under the administrative control of Director of Medical and Rural Health Services to administrative control of Director of Medical Education and requested to rename the above Government Taluk Hospital, Chennai as Government Peripheral Hospital, Saidapet, Chennai attached the administrative control of Government Royapettah Hospital, Chennai.

5. The Director of Medical and Rural Health Services has therefore requested the Government to consider the matter on administrative grounds at this pandemic situation in order to ease the health / administrative activities in day to day administration and considering the same on financial aspect due to execution of IFRHMS process and to issue suitable orders for transferring the Government Hospital, Saidapet, Chennai which is functioning under the administrative control of Director of Medical and Rural Health Services to administrative control of the Director of Medical Education, Chennai-10 with effect from 01.06.2021.

6. The Government after careful consideration direct that Government Hospital, Saidapet, Chennai which is now functioning under the control of Director of Medical and Rural Health Services, be transferred to the administrative control of Director of Medical Education along with infrastructure facilities like Site, Building, Equipments, Vehicles, Sanctioned Posts and Medical, Para-Medical and Administrative staff.

7. The Government also permit to rename the Government Hospital, Saidapet, Chennai as Government Peripheral Hospital, Saidapet, Chennai attached to the administrative control of Government Royapettah Hospital, Chennai.

8. The Director of Medical Education / Director of Medical and Rural Health Services are directed to take necessary action accordingly.
