#### **ORDER:**

The Chairman, Pachamuthu Educational Trust, Dharmapuri has requested the Government to grant permission to start four years B.Sc (Nursing) course in the name and style as "Pachamuthu College of Nursing, Dharmapuri" with an annual intake of 60 students from the academic year 2019-2020.

2. In its Government letter sixth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to fifth read above and the Indian Nursing Council, New Delhi.

- 3. In his letter seventh read above, the Director of Medical Education has submitted the proposal in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to grant permission to the Chairman, Pachamuthu Educational Trust, Dharmapuri to start four years B.Sc (Nursing) course in the name and style as "Pachamuthu College of Nursing, Dharmapuri" with an annual intake of 60 students from the academic year 2019-2020.
- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Chairman, Pachamuthu Educational Trust, Dharmapuri to start 4 years B.Sc (Nursing) course with an annual intake of 60 (sixty) students in the name and style as "Pachamuthu College of Nursing" in the existing pharmacy college building in ground floor (Phase-I) in S.F. No.178/3A, Nallanahalli Village, Semmandakuppam Panchayat, Dharmapuri Taluk and District for 10 years from the academic year 2019-2020. Accordingly, the Government do and hereby direct that the Chairman, Pachamuthu Educational Trust, Dharmapuri is permitted to start 4 years B.Sc (Nursing) course with an annual intake of 60 (sixty) students in the name and style "Pachamuthu College of Nursing" in the existing pharmacy college building in ground floor (Phase-I) in S.F. No.178/3A, Nallanahalli Village, Semmandakuppam Panchayat, Dharmapuri Taluk and District for 10 years from the academic year 2019-2020, subject to the following conditions:-
  - The Trust should obtain building plan approval from the Directorate of Town and Country Planning for new separate building in S.F.No.178/1, Nallanahalli Village, Semmandakuppam Panchayat, Dharmapuri Taluk and District (after 10 years change of building) within a period of 10 years for the proposed nursing college.
  - ii. The Trust should obtain the building completion certificate from the competent authority for the existing pharmacy college and proposed nursing college.
  - iii. The Trust should construct a new separate academic building and hostel facilities for boys and girls in the name of "Pachamuthu College of Nursing" in S.F. No.178/1 before completion of 10 years, as per the undertaking given by the Trust member and should obtain permission from the State Government in this regard.
  - iv. Admission of students shall be made as per the rules fixed by the Government from time to time.
  - v. Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said nursing college.

- vi. The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, and Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively before admitting the students.
- vii. The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.
- viii. The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- ix. The Trust should not run any other Nursing institution within 10 kms radius.
- x. The Trust should construct 100 bedded own hospital within a period of 3 years.
- 5. The Director of Medical Education is directed to take necessary further action accordingly.
