### ORDER:-

In the Government Orders first and second read above, among others, the Government sanctioned the post of Assistant Surgeon (Obstetrics and Gynaecology) and Assistant Professor of Physiology to the Thiruvannamalai Medical College and Hospital, Thiruvannamalai.

- 2. The Director of Medical Education has stated that Dr.R.Lakshmi, MD (Dermatology), formerly Senior Civil Surgeon (Self Drawing Officer), Government Hospital, Cheyyar, on release from the Directorate of Medical and Rural Health Services, has been transferred and posted as Tutor / Assistant Professor of Physiology (Non-Self Drawing Post) at Government Thiruvannamalai Medical College, Thiruvannamalai in the permanent post sanctioned vide Government Order second cited. She joined duty as Tutor / Assistant Professor of Physiology at Government Thiruvannamalai Medical College, Thiruvannamalai on the forenoon of 16.10.2014.
- 3. The Director of Medical Education has further stated that Dr.R.Lakshmi, MD (Dermatology), who was working as Assistant Professor of Physiology has been subsequently transferred and posted as Senior Resident in the Department of Dermatology, Government Thiruvannamalai Medical College, Thiruvannamalai. Accordingly, she has joined duty in the post of Senior Resident in Dermatology, Thiruvannamalai Medical College, Thiruvannamalai on the forenoon of 09.06.2015. As the Grade Pay of Senior Civil Surgeon and Assistant Professor is different and the individual could not draw salary, she has addressed the Government in this regard.
- 4. The posts of Senior Resident, Assistant Professor and Senior Civil Surgeon have the same scale of pay (i.e.,) Rs.15600-39100. However, the Grade Pay of the post of Senior Resident is Rs. 5400/-, Assistant Professor is Rs.5700 and Senior Civil Surgeon is Rs.7600/-. But the post of Associate Professor has the Grade Pay of Rs.7600/-(scale of pay Rs.15600-39100+GP.7600), identical to that of the post of Senior Civil Surgeon held by Dr.R.Lakshmi.

- 5. The Government have carefully examined the proposal of the Director of Medical Education. For the purpose of claiming salary, the Government accord sanction for
  - (i) upgradation of the post of Assistant Professor of Physiology sanctioned vide G.O.(Ms) No.71, Health and Family Welfare Department, dated 09.04.2013 as Associate Professor of Physiology / Senior Civil Surgeon for the period 16.10.2014 to 08.06.2015 in the scale of pay of Rs.15600-39100+GP.7600/- and
  - (ii) upgradation of the post of Senior Resident in Dermatology originally created as Assistant Surgeon (Obstetrics and Gynaecology) sanctioned in G.O.(Ms) No.1721, Health and Family Welfare Department, dated 29.10.1985 and subsequently redeployed as Senior Resident in Dermatology in the office of the Director of Medical Education Proceeding No.2718/E3/1/2014, dated 09.07.2014, as Associate Professor/Senior Civil Surgeon with effect from 09.06.2015 in the scale of pay of Rs.15600-39100+GP.7600/-, subject to the condition that the said post shall be downgraded as Senior Resident in Dermatology in the scale of pay of Rs.15600-39100+GP.5400/- as and when Dr.R.Lakshmi moves from that post.
- 6. This order issues with the concurrence of Finance Department vide its U.O.No.421/CMPC/2016, dated 05.01.2016.
