In the circumstances reported by the Director of Public Health and Preventive Medicine, the following amendment is issued to the G.O.(4D)No.29, Health and Family Welfare Department, dated 18.10.2013:

AMENDMENT

- 1. The para 3 mentioned in G.O.(4D)No.29, Health and Family Welfare Department, dated 18.10.2013, shall be substituted with the following para:
 - "3. The Government have examined the proposal of the Director of Public Health and Preventive Medicine carefully and independently and decided to regularize the services of the following Medical Officers by relaxing the rule 7(a) of Special Rules for Tamil Nadu Medical Service relating to age in favour of them. The Government accordingly do and hereby direct that the temporary services of the following Medical Officers in Tamil Nadu Medical Service be regularized from the date of their appointment mentioned against each of them by relaxing the rule 7(a) of Special Rules for Tamil Nadu Medical Service relating to age in favour of them:

Meera and Dr. Helen Hubert, so as to enable them to have their temporary service in Tamil Nadu Medical Service regularised".
