## **ORDER:**

In the letter first read above Essentiality Certificate has been issued to increase of MBBS seats from 100 to 150 at Kanyakumari Government Medical College, Asaripallam, Kanyakumari from the academic year 2020-2021. The Director of Medical Education in his letter second read above has requested to sanction a total sum of Rs.5,96,000/- (Rupees Five lakhs and ninety six thousand only) at the of Rs.2.36/- lakhs (Rupees Two lakhs thirty six thousand only) towards Application fees, payable to the Board of Governors In Supersession of Medical Council of India, New Delhi and Rs.3.60/- lakhs (Rupees Three lakhs sixty thousand only) towards Affiliation fees, payable to the Tamil Nadu Dr.M.G.R. Medical University, Chennai for submission of application to the Board of Governors In Supersession of Medical Council of India, New Delhi from the Personal Deposit Account of the Directorate of Medical Education, being maintained by the Secretary, Selection Committee, Office of Directorate of Medical Education, Chennai, with a instruction to the Dean, Kanyakumari Government Medical College, Asaripallam, Kanyakumari to reimburse the above said amount after obtaining funds from Revised Estimate / Final Modified Appropriation, 2019-2020, without fail.

2. The Government have examined the proposal of the Director of Medical Education and decided to accept the same. Accordingly, the Government hereby grant permission to the Director of Medical Education to incur an expenditure of Rs.5,96,000/- (Rupees Five lakhs and ninety six thousand only) at the rate of Rs.2.36/- lakhs (Rupees Two lakhs thirty six thousand only) towards Application fees, payable to the Board of Governors In Supersession of Medical Council of India, New Delhi and Rs.3,60,000/- lakhs (Rupees Three lakhs sixty thousand only) towards Affiliation fees, payable to the Tamil Nadu Dr.M.G.R. Medical University, Chennai for submission of application to the Board of Governors In Supersession of Medical Council of India, New Delhi

For the amount so sanctioned in para 2 above, the Director of Medical Education is directed to initially incur the expenditure from the Personal Deposit Account of the Director of Medical Education maintained by the Secretary, Selection Committee and the Dean, Kanyakumari Government Medical College, Asaripallam, Kanyakumari is directed to reimburse the above said amount after obtaining funds from Revised Estimate / Final Modified Appropriation, 2019-2020, without fail
- 4. The Director of Medical Education is directed to take necessary action accordingly.
