#### **ORDER:**

In G.O. first read above, orders were issued constituting a committee to look into promotional opportunities of Government Doctors at various levels. In G.O. second read above, based on the recommendation of the Committee, orders were issued giving time bound promotion to the Medical Officers working in the Health and Family Welfare Department.

2. In Government Order third read above, certain clarifications to the Government Order second read above were issued that the Assistant Surgeon Medical Officers working in the Tamil Nadu Medical Service of all the Directorates shall be given time bound promotion on completion of 8, 15, 17 years of eligible service in the designation/scales of Senior Assistant Surgeon Pay Band-III Rs.15600 – 39100 + Grade Pay of Rs.5700/-, Civil Surgeon Pay Band-III Rs.15600 – 39100 + Grade Pay of Rs.6600/- and Senior Civil Surgeon Pay Band-III Rs.15600 – 39100 + Grade Pay of Rs.7600/- respectively and on completion of 20 years of eligible service as Chief Civil Surgeon in Pay Band-IV Rs.37400 – 67000 + Grade Pay of Rs.8700/-.

3. In Government letter fourth read above, certain clarifications were issued that the date of effect of G.O. third read above is prospective effect only (i.e.) date of issue of the order (30.10.2013).

4. In their representation fifth read above, the Tamil Nadu Government Doctors Association has requested to give the retrospective effect to the G.O. third

read above, since the said G.O. is an only the clarificatory orders for G.O. second read above.

5. The Government have examined the request of the Association in consultation with Finance Department and decided to give the retrospective effect to the G.O. third read above. Accordingly, the Government do and hereby ordered as follows:

- i. To give effect to the G.O. (Ms) No.245, Health and Family Welfare Department, dated 30.10.2013, for getting time bound promotion with monetary benefits to the Medical Officers who have completed the 8 / 15 / 17 / 20 years before 23.10.2009 to the post of Senior Assistant Surgeon / Civil Surgeon / Senior Civil Surgeon / Chief Civil Surgeon respectively from the date of completion of the above said period subject to the condition that monetary benefit may be given to them w.e.f. 23.10.2009 (i.e.) the date of issue of G.O. (Ms) No.354, Health and Family Welfare Department, dated 23.10.2009 and those who have completed the required service after 23.10.2009 they shall get the monetary benefit from the next date of completion of 8/15/17/20 years in the cadre of Senior Assistant Surgeon / Civil Surgeon / Senior Civil Surgeon / Chief Civil Surgeon respectively.
- ii. It is also clarified that while the time bound fixation of pay for all categories (8, 15, 17, 20) will be given as per para (i) above and the promotions to the substantive posts would be subject to the availability of vacancies only, irrespective of pay.
