### **ORDER:**

In the Government order first read above, orders have been issued for the constitution of Medical Services Recruitment Board exclusively for Health and Family Welfare Department so as to centralize the mode of direct recruitment to all categories existing in Health and Family Welfare Department except those that are coming under the purview of Tamil Nadu Public Service Commission. Subsequently in the Government order second read above Rules of Procedures of Medical Services Recruitment Board for recruitment of various categories have been issued. Later in the Government order third read above amendment to Rules of Procedure have been issued.

2. In the Government order fourth read above, Government approve the Notification of the Medical Services Recruitment Board for filling up of the 353 vacancies to the post of Pharmacist in Tamil Nadu Medical Subordinate Service by direct recruitment and Medical Services Recruitment Board has issued Notification No.13/MRB/2019, dated 01.03.2019. Subsequently in the Government order fifth read above, Government approve the corrigendum to the Notification No.13/MRB/2019, dated 01.03.2019 of the Medical Services Recruitment Board, inviting online applications only from eligible candidates with "B.Pharm" Degree and registered his/her name in the Tamil Nadu Pharmacy Council on or before

Dela cost

01.03.2019 for direct recruitment to the post of Pharmacist, subject to the outcome of W.P.No.8746 of 2019.

- 3. In his letter sixth read above, the Chairman, Medical Services Recruitment Board has stated that 23,008 online applications have been received from the candidates for filling up of the 353 vacancies of Pharmacist post. Hence selection of the candidates through weightage method will lead to certain ambiguity among the candidates in arriving the merit list. Moreover, the maximum marks for the Diploma and Degree in certain institutions are entirely different. Also, there are chances for requesting to give preferential marks for the degree holders and proposed that selection for the post of Pharmacist may be made by conducting written competitive examination by issuing necessary amendment to the Rules of Procedure of Medical Services Recruitment Board.
- 4. The Government have examined the proposal of the Chairman, Medical Services Recruitment Board in detail and permit the Chairman, Medical Services Recruitment Board to conduct written competitive examination for recruitment of Pharmacist by relaxation of procedure approved in the Rules of Procedure of Medical Services Recruitment Board as a one time measure.
