ORDER:

The Founder / Managing Trustee, Vettrivinayahar Educational and Charitable Trust, Anaikkarai, Thanjavur District has requested the Government to grant permission to start two years Diploma in Medical Laboratory Technology course in the name and style as "Venkateswara College of Allied Health Sciences, Anaikkarai, Thanjavur District" with an annual intake of 15 students from the academic year 2019-2020.

- 2. In its Government letter first read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request.
- 3. The Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Allied Health Sciences has fulfilled the conditions prescribed by the Government norms and has submitted the proposal with the Inspection Report / Project Report along with his specific recommendation to the Government and requested to issue necessary orders.
- 4. In his letter second read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled all the norms prescribed by the Government and recommended to grant permission to the Founder / Managing Trustee, Vettrivinayahar Educational and Charitable Trust, Anaikkarai, Thanjavur District to start 2 years Diploma in Medical Laboratory Technology course at Venkateswara College of Allied

Health Sciences, Anaikkarai, Thanjavur District with an annual intake of 15 students from the academic year 2019-2020.

- 5. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Founder / Managing Trustee, Vettrivinayahar Educational and Charitable Trust, Anaikkarai, Thanjavur District to start 2 years Diploma in Medical Laboratory Technology course with an annual intake of 15 (fifteen) students in the name and style as "Venkateswara College of Allied Health Sciences" in R.S.Nos.122/2, 131/1, 131/2A and 132/2A, Vinayagan Theru Village and Panchayat, Thiruvidaimarthur Taluk, Anaikkarai, Thanjavur District 612 502 from the academic year 2019-2020, subject to the following conditions, before admitting the students:
 - i. The Trust should obtain the building completion certificate from the competent authority ie. PWD authority.
 - ii. The Trust should obtain the academic building plan and hostel building plan approval from the Directorate of Town and Country Planning.
 - iii. The Trust should obtain Clearance Certificate from State Pollution Control Board for the proposed Paramedical Institution.
 - iv. The Trust should provide adequate library books.
- 6. The Director of Medical Education is directed to take necessary further action accordingly.
