ORDER:

The Director of Medical Education has stated that the post of Financial Advisor and Chief Accounts Officer in the office of the Directorate of Medical Education has been created in G.O. (Ms) No. 2241, Health and Family welfare department, dated: 27.11.1969. Earlier, there were only six Medical Colleges and Hospitals and few allied institutions attached to them, under the control of Directorate of Medical Education and the total staff strength of these institutions, from Dean to last grade servants, were only in hundreds. Now, the scenario has changed as stated below:-

- the Directorate of Medical Education currently administers 19 Medical Colleges and 51 Medical College Hospitals and Government Dispensary.
- the Tamil Nadu Dental College Hospital, two Physiotherapy Colleges, four Nursing colleges and 23 School of Nursing which are run by the Government are also managed by the Directorate of Medical Education. Proportionately, the Staff strength too has increased.
- the Government aims to start a New Medical College in each district. Simultaneously, the staff strength is bound to increase year by year with the opening of new Medical College, various speciality departments, new School / College of Nursing. The staff strength under the administrative control of this Directorate is also increasing year by year.

- At present the budget allocation for the Directorate of Medical Education alone, in this financial year (2014-2015) is Rs.2070/- crores. The Budget allocation and its related works like appropriation, reconciliation, Plan scheme expenditure etc., for more than 65 institutions, under the control of Directorate of Medical Education, are managed by one Financial Advisor and Chief Accounts Officer.
- Other than that, the Financial Advisor and Chief Accounts Officer looks after the works related to Tenders, Loans and Advances, G.P.F., Audit etc.,
- The responsibility and the work load of Financial Advisor and Chief Accounts Officer have increased, with the creation of Tamil Nadu Medical Services Corporation, Tamil Nadu State Aids Control Society, Tamil Nadu Health Systems Project, National Rural Health Mission, etc.,

2. The Director of Medical Education has therefore requested the Government to sanction one post of Chief Accounts Officer in the cadre of Under Secretary to the Directorate of Medical Education.

3. The Government have examined the proposal of Director of Medical Education in detail and accord sanction for upgradation of one post of Accounts Officer as Chief Accounts Officer in the scale of pay of Rs.15600-39100+ Grade Pay Rs. 6600/-, be filed in the cadre of Under Secretary to Government from the Finance Department to the Directorate of Medical Education, Chennai.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“2210 – Medical and Public Health – 05 – Medical Education, Training and Research – 001 – Direction and Administration – I-Non-Plan- AA Directorate of Medical Education – 01 – Salaries.” (DPC 2210- 05 – 001 – AA 0103)
