ORDER:

The Chairman, Alamelu Ammal Educational Trust, Nagapattinam has applied for permission to start Auxiliary Nurse Midwife Training Course in the name of "Andavar College of ANM" with an annual intake of 60 students per batch / per year.

- 2. In the letter fourth read above, the Director of Public Health and Preventive Medicine has stated that the Chairman, Alamelu Ammal Educational Trust, Nagapattinam has applied for permission to start Auxiliary Nurse Midwife Training Course in the name of "Andavar College of ANM" with an annual intake of 60 students per batch / per year and the Institution has submitted the application duly filled in the prescribed format and the Joint Director of Public Health and Preventive Medicine (Training) has inspected the above Institution on 1.6.2018 and the guidelines for the course have been followed and necessary supporting documents have also been furnished by the Institution.
- 3. The Director of Public Health and Preventive Medicine has also recommended and requested to accord permission to the Chairman, Alamelu Ammal Educational Trust, Nagapattinam to start Auxiliary Nurse Midwife Training Course in

the name of "Andavar College of ANM" with an annual intake of 60 students per batch / per year, subject to the following conditions:-

- The Institution should obtain approval from the Indian Nursing Council, New Delhi and Registrar, Tamil Nadu Nurse and Midwives Council, Chennal before starting the course.
- ii. The examination can be conducted for the trainees who are undergoing the Auxiliary Nurse Midwife course in the above said Private Nursing School by the Director of Public Health and Preventive Medicine being the Chairman of Board of Examination.
- iii. To conduct exams for ANM Course, subject to the following conditions:
 - a) The internship for these trainees should be conducted in an Upgraded Government Primary Health Centres / Community Health Centres for a period of at least three months.
 - b) The trainees should undergo field practice in the identified Government Primary Health Centres only after paying the prescribed fees.
 - c) The Private Nursing Schools should construct building in the Affiliated Community Health Centres for accommodating the trainees.
 - d) The Institution and the candidates should pay the examination fees at the rate of Rs.1000/- per paper per semester and other fees prescribed by the Government from time to time.
- 4. The institution has submitted the following particulars as stipulated in the G.Os 1st to 3rd read above:
 - i. The undertaking is given in Rs.75/- Judicial stamp papers instead of Rs.5/- Judicial Stamp paper, as per the stipulations in guidelines.
 - ii. An endowment fund for Rs.5/- lakh (Rupees Five lakh only) in the joint name of the Trust/Private Management and pledged in favour of the Director of Public Health and Preventive Medicine (in his official capacity)
 - iii. Building Plan showing of class rooms, laboratories and library duly approved by the Panchayat President, Poravachery.
 - iv. Building Plan showing of hostel and mess facilities duly approved by the Special Officer / Block Development Officer (Village Panchayat), Poravachery.
 - v. The Experience and Qualification Certificates of Principal and Tutors as per Indian Nursing Council norms.
- 5. The Government, after careful examination, have decided to accept the recommendation of the Director of Public Health and Preventive Medicine and hereby direct that the Chairman, Alamelu Ammal Educational Trust, Nagapattinam be permitted to start Auxiliary Nurse Midwife Course in the name of "Aandavar College of ANM" with an annual intake of 60 students per batch from the Academic Year 2018-19, subject to fulfillment of the conditions prescribed in G.Os. 1st to 3rd read above along with the following conditions:-
 - (i). The Institution should submit the Building Plan for Class rooms, Laboratories, Library and Hostel approved by the Director of Town and Country Planning, before admitting the students for the above said course;

- (ii) The Institution should submit the Building Completion Certificate issued by the Competent authority, before admitting the students for the above said course.
- (iii). The Director of Public Health and Preventive Medicine should ensure that the infrastructure of Hostel Premises in the above Institution is in existence as per the Inspection report of the Deputy Director of Health Services, Nagapattinam, as to whether the above Institution has submitted the Building Plan and Building Completion Certificate duly approved by the Director of Town and Country Planning before admitting the students in the course.
