ORDER:

In the Government Order first and second read above and subsequently amended in Government Order 3^{rd} and 6^{th} read above, orders were issued relaxing the Rule 5(a) (pertaining to age qualification) of Adhoc Rule to the post of Village Health Nurses for having appointed 330 (236 + 94) over aged Village Health Nurses from the date of issue of order.

2. The Director of Public Health and Preventive Medicine in his proposals in the Jetters 4th and 5th read above has stated that the post of Village Health Nurses are being filled up from Community Nutrition Worker / Anganwadi Workers after having given Multipurpose Health Workers (Female) Training. They were not newly recruited candidates. As such, the appointment made is to be considered as transfer of service. They were within the age limit of 35 years, while they were selected for the training. Only due to the administrative reason, the posting orders for appointment as Village Health Nurse were not issued immediately on completion of their training. In view of belated issue of postings, some of them crossed the maximum age limit of 40 years on the date of their appointment to the post of Village Health Nurses. Hence, the Director of Public Health and Preventive Medicine has

requested the Government to relax the rule 5(a) of Adhoc rules to the post of Village Health Nurses pertaining to the age qualification for the above 330 (236 + 94) over aged Village Health Nurses from the date of their appointment, instead of the date of issue of the order.

3. The Government after detailed examination of the case, have decided to accept the proposal of the Director of Public Health and Preventive Medicine as a special case and accordingly issue the following order:-

"The rule 5(a) of Adhoc rule relating to age qualification for the post of Village Health Nurse in Tamil Nadu Public Health Subordinate Service is hereby relaxed from the date of the appointment in the post of Village Health Nurses in respect of 94 Village Health Nurses who were appointed during the year 2004 and 236 Village Health Nurses who were appointed during the years 2006 – 2007 from the category of Community Nutrition Worker/Anganwadi Workers so as to regularise their services "in the post of Village Health Nurse" from the actual date of appointment.
