ORDER:-

In Government Order 1st read above, Government have formed a sub-committee at State and District level for National Programme for prevention and control of Deafness. In Government Order 2nd read above, Government have permitted the Mission Director, State Health Society, Tamil Nadu to appoint one Audiometric Assistant and one Instructor for the Young hearing Impaired in each of the 19 Districts namely Vellore, Villupuram, Thanjavur Coimbatore, Cuddalore, Dharmapuri, Dindigul, Erode, Madurai, Nagapattinam, Namakkal, Pudukottai, Ramanathapuram, Salem, The Nilgiris, Tiruvarur, Trichy, Tirunelveli and Tiruvannamalai on consolidated pay of Rs.7500/- per month. Subsequently, in Government Order 3rd read above, Government amended the Government Order 2nd read above regarding "the recruitment of above post may be made from Employment Exchange only with rule of reservation to be followed".

- 2. In Government Order 4th read above, Government permitted the Mission Director, State Health Society to appoint 31 post of Audiologist at one per District with the consolidated pay of Rs.9000/- per month and the posts shall be filled up through outsourcing.
- 3. The Mission Director, State Health Society in his letter 5th read above has stated that National Programme for Prevention and Control of Deafness Programme is being implemented in a phased manner since 2008 under National Health Mission, based on the Government Orders / Executive Committee approval, during the course of its implementation. The National Programme for Prevention and Control of Deafness Programme is covered in a phased manner as detailed below:-

- 4. The Mission Director, National Health Mission has also stated that the programme has to be implemented with following provisions:-
 - A. Infrastructural Development
 - B. Recruitment of exclusive HR for National Programme for Prevention and Control of Deafness
 - C. Capacity building of Institutions holding National Programme for Prevention and Control of Deafness corners including support for manpower and training
 - D. Supply ENT equipment and Kits
- 5. The Mission Director, State Health Society has also stated that in the supplementary RoP 2016-17, the Government of India has approved Rs.13.95 lakh for 31 posts of Instructor for Young Hearing Impaired at the rate of one per District with salary of Rs.15000/ month for 3 months.
- 6. The Mission Director, State Health Society has also stated that the following proposals were placed in the 32nd Executive Committee meeting vide agenda No.24 and the same was approved:
 - i. To authorize him to appoint additional 12 District level posts of Instructor for Young Hearing Impaired at the rate of one per District through District Health

- Society through outsourcing with a consolidated pay of Rs.15,000/- per month with 5% annual increment.
- ii. To revised the salary from Rs.7,500/- to Rs.15,000/- for the sanctioned 19 District level posts of Instructor for Young Hearing Impaired.
- iii. To revised mode of recruitment from 'through Employment exchange with rule of reservation' to 'Outsourcing through District Health Society' for the sanctioned 19 District level posts of Instructor for Young Hearing Impaired
- 7. The Mission Director, State Health Society has therefore requested necessary orders in this regard.
- 8. After careful examination the Government have decided to accept the proposal of Mission Director, National Health Mission and accordingly issue the following orders:
 - i. 12 new posts (Contract) of Instructor for young hearing impaired- are created @Rs.10,000/ per month with annual increment of Rs.500/- for the remaining 12 Districts (Kancheepuram, Kanyakumari, Karur, Krishnagiri, Perambalur, Sivagangai, Thoothukudi, Theni, Virudhunagar, Thiruvallur, Thiruppur & Ariyalur).
 - ii. The salary of the 19 existing posts of Instructor for Young Hearing Impaired be revised from Rs.7500/- to Rs.10000/- per month with annual increment of Rs.500/-
 - iii. Appointment shall be made through Employment Exchange with rule of reservation.
- 9. This order issues with the concurrence of the Finance Department vide its U.O. No.14835/Health-I/18, dated : 05.07.2017.
