ORDER :

The Chairman, Shenbagha College of Nursing, Chennai has requested Government to grant permission for change of address of "Shenbagha College of Nursing" from No. 14, Hostel Street, Vellappanchavadi, Chennai to its own building at Mettu Street, Mathiravedu, Chennai 77.

2. The Director of Medical Education has constituted an inspection team to verify as to whether the proposed College of Nursing, at the new site has fulfilled the conditions prescribed by the Government and the Indian Nursing Council, New Delhi and submitted the proposal along with the Inspection report / Project Report along with her specific recommendations to the Government and requested Government to issue necessary orders for the change of address of Shenbagha College of Nursing from No. 14, Hostel Street, Vellappanchavadi, Chennai to its own building at Mettu Street, Mathiravedu, Chennai- 77.

3. The Government have examined the case in detail in the light of the recommendation of the Inspection Officers and the Director of Medical Education and accepted the request of the Chairman, Shenbagha College of Nursing, Chennai and permit the above College to change the site from "No.14, Hostel Street, Vellappanchavadi, Chennai" to its own building at "Mettu Street, Mathiravedu, Chennai 77" to conduct B.Sc., (N) course from the academic year 2014-2015, subject to the following conditions:-

- a) The Trust should obtain recognition / suitability / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, Indian Nursing Council, New Delhi and Tamil Nadu Dr. M.G.R. Medical University respectively for the new address.
- b) The Trust should not run any other Nursing institution within 10 km radius.
- c) Construction of hostel building should be completed before December 2014.
- d) Own vehicle should be purchased before April 2015.

4. The Director of Medical Education is directed to take necessary action accordingly.
