ORDER:

The Managing Trustee, Hindusthan Educational and Charitable Trust, Coimbatore has requested the Government to grant permission to start four years B.Sc (Nursing) course in the name and style as “Hindusthan College of Nursing, Udayampalayam Road, Nava India, Coimbatore” with an annual intake of 60 students from the academic year 2019-2020.

2. In its Government letter sixth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to fifth read above and the Indian Nursing Council, New Delhi.

3. In his letter seventh read above, the Director of Medical Education has submitted the proposal in which he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to grant permission to the Managing Trustee, Hindusthan Educational and Charitable Trust, Coimbatore to start four years B.Sc (Nursing) course in the name and style as "Hindusthan College of Nursing, Udayampalayam Road, Nava India, Coimbatore" with an annual intake of 60 students from the academic year 2019-2020.

4. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and decided to grant permission to the Managing Trustee, Hindusthan Educational and Charitable Trust, Coimbatore to start four years B.Sc (Nursing) course with an annual intake of 60 (sixty) students in the name and style as Hindusthan College of Nursing in the existing Hindusthan Hospital building in 5th floor in S.F.No.522/3PT, Udayampalayam Road, Nava India, Coimbatore from the academic year 2019-2020. Accordingly, the Government do and hereby direct that the Managing Trustee, Hindusthan Educational and Charitable Trust, Coimbatore to start four years B.Sc (Nursing) course with an annual intake of 60 (sixty) students in the name and style as Hindusthan College of Nursing in the existing Hindusthan Hospital building in 5th floor in S.F. No.522/3PT, Udayampalayam Road, Nava India, Coimbatore from the academic year 2019-2020, subject to the following conditions:-

- a) The Trust should obtain the building completion certificate from the competent authority for academic building and Hostel building of Hindusthan College of Nursing, Coimbatore and submit to the Government before admitting the students.
- b) The Trust should have adequate Library books as per norms of Indian Nursing Council.
- c) Admission of students shall be made as per the rules fixed by the Government from time to time.
- d) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students who seek admission in the said nursing college.
- e) The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai, and Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively before admitting the students.

- f) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like, winding of course without valid reasons etc.
- g) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- h) The Trust should not run any other Nursing institution within 10 kms radius.

5. The Director of Medical Education is directed to take necessary further action accordingly.
