National Health Mission –Tamil Nadu – Upgradation and addition facilities to Primary Health Centres - Constructing Out Patient Blocks to 5 Primary Health Centres and Staff Nurse Quarters to 5 Primary Health Centres Sanctioned – Orders – Issued.

ORDER:

In the letter read above, the Mission Director, National Health Mission has stated that it is necessary to provide additional facilities such as, Out Patient buildings, staff nurse quarters, maternity block etc., to the Primary Health Centres, in order to cope with the demand for service in the Primary Health Centres. Thus, in some Primary Health Centres, the Out Patient Blocks are either inadequate to accommodate all the services – such as Non Communicable Disease, Dental and AYUSH services or they are in dilapidated condition. Besides, in order to provide residential facilities to the staff nurses in Primary Health Centres so as to help them reside in the vicinity / premises of Primary Health Centres for delivering health services on 24 X 7 basis.

2. The Hon'ble Minister, Health and Family Welfare Department has announced on the floor of the Assembly on 14.06.2018 that the Out Patient blocks will be constructed in 5 Government Primary Health Centre at Kaveripattinam in Krishnagiri District, Kanai in Villupuram District, Adhamangalampudur and Kalasapakkam in Thiruvannamalai District and Sathirapatti in Virudhunagar District at a cost of Rs.3 crore. The Mission Director, National Health Mission has also stated that the proposals are approved in Record of Proceedings by the National Program Coordination Committee (NPCC) of Government of India, for providing Out Patient Blocks to 5 Primary Health Centres and staff nurse quarters (Twin type) to 5 Primary Health Centres as detailed below:-

3. The Mission Director, National Health Mission has therefore requested necessary Government orders in this regard.

4. The Government after careful consideration have decided to accept the proposal of the Mission Director, State Health Society and accordingly issue following orders:-

- i. The Mission Director, State Health Society – Tamil Nadu, Chennai is permitted to construct Out Patient Block to 5 Primary Health Centres at a rate of Rs. 60 lakh each and Staff Nurse Quarters (Twin Type) at the rate of Rs.22.23 lakh each to 5 Primary Health Centres at the following places:-

- ii. Sanction is accorded for a sum of Rs.171.15 lakh (Rupees One hundred and seventy one lakh and fifteen thousand only) to carry out the civil works as detailed below.
- Construction of Out Patient Blocks to 5 Primary Health Centres -Rs.60.00 lakh
 - Construction of Staff Nurse Quarters to 5 Primary Health Centres -Rs.111.15 lakh
- iii. The Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions for the drawal of funds (20% of total cost) (Rupees Sixty lakhs only).

- iv. The Mission Director, State Health Society – Tamil Nadu, Chennai is permitted to remit the balance of funds required for constructing Out Patient Blocks in 5 Primary Health Centres as and when the funds are approved by Government of India.

5. The amount sanctioned in para 4 (ii) above shall be debited to the following Head of Account.

"4211-00 Capital outlay on family welfare -103- Maternity and Child Health State's Expenditure – AA Civil Works under National Health Mission Scheme – 16 major works"
