The Government now accord sanction for a sum of Rs.7,50,000/- (Rupees Seven Lakhs and fifty thousand only) from the Chief Minister's Public Relief Fund towards the payment of annual grant to Cancer Institute, Adyar for the year 2013-14 for undertaking free cancer drug treatment subject to the condition that the institute shall

give free treatment to the persons below poverty line and send the list of persons to whom such free treatment is given to the Government and that the grant should be fully utilized for the treatment of the poor persons.

The Joint Secretary to Government and Treasure, Finance(Chief Minister's Public Relief Fund) Department, Chennai – 9 is directed to draw a cheque for a sum of Rs.7,50,000/-(Rupees seven lakhs and fifty thousand only) from the Chief Minister's Public Relief Fund in favour of the Executive Chairman, Cancer Institute(WIA), Adyar, Chennai and to send the same under proper acknowledgement.

4. The utilization of the annual standing grant sanctioned in paragraph-2 above shall be subject to the guidelines formulated in G.O.1st cited and the instruction in the Government letter 2nd read above. The utilization certificate shall be sent to the Government in due course.
