## ORDER:

The Director of Medical Education has sent the proposal for creation of 53 posts in various categories to Chengalpattu Medical College, Chengalpattu towards the increase of number of MBBS seats from 50 to 100.

- 2. The Director of Medical Education has stated that the proposal received from the Dean, Chengalpattu Medical College, Chengalpattu has been verified with Medical Council of India norms. He has requested the Government to accord necessary administrative and financial sanction for the creation of posts to Chengalpattu Medical College, Chengalpattu.
- 3. The Government, after careful examination of the proposal of the Director of Medical Education, accord sanction for creation of eleven posts to Chengalpattu Medical College, Chengalpattu as detailed below, on a permanent basis, at an immediate cost of Rs. 71.27 lakhs per annum (Rupees Seventy One Lakhs and Twenty Seven Thousand only):-

4. The expenditure towards pay and allowances of posts sanctioned in para 3 above shall be debited to the following head of account:-

"2210 – Medical and Public Health – 05 – Medical Education, Training and Research – 105 Allopathy– I Non Plan–AE – Chengalpattu Medical College, Chengalpattu – 01 Salaries" (DPC 2210 – 05 – 105 – AE-0105)

- 5. The expenditure sanctioned in para 3 above constitute an item of "New Instrument of Service" and approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund, orders regarding which will be issued by Finance (BG-I) Department. The Director of Medical Education is directed to send an application in the prescribed form along with the copy of this order to Finance (BG-I) Department for sanctioning the advance for required quantum. The Director of Medical Education is also directed to send necessary note for inclusion of the expenditure in the Supplementary Estimate to obtain approval of the Legislature at the appropriate stage.
