ORDER:

The Mission Director, State Health Society in his letter read above has stated that the Central funds under the Centrally sponsored Schemes like National Health Mission are routed through the Treasury route as part of the State plan and requested to provide for central share of National Health Mission in the State Budget. The Government of India have transferred a sum of Rs.12,44,000/- into State Government account as its 75% share of Grants-in-aid for the drawal of amount through Treasury route for the financial year 2014-15 for the Creation of Capital Assets for National Programme for Prevention and Control of Deafness under Non Communicable Disease flexipool of National Health Mission for the year 2014-15. The Government of India has requested to ensure 25% State contribution based on the release of funds by Government of India. The Mission Director, State Health Society has stated that the corresponding 25% of the State Share against the 75% of the Government of India release of Rs.12,44,000/- (Rupees Twelve Lakh and Forty Four Thousand only) works out to Rs.4,14,667/- (Rupees Four Lakh Fourteen Thousand Six Hundred and Sixty Seven only). Since Government of India has transferred the grants to State Government for drawal of amount through Treasury route from 2014-15, the amount of Central and State share will have to be drawn from State Budget.

2. The Mission Director, State Health Society has requested the Government to issued orders for the release of a sum of Rs.16,58,667/- (Rupees Sixteen Lakh Fifty Eight Thousand Six Hundred and Sixty Seven only) towards release of Central and State contribution of grants in aid to the State Health Society for the year 2014-15 for

Creation of Capital Assets for National Programme for Prevention and Control of Deafness under Non Communicable Disease flexipool of National Health Mission for the year 2014-15 and to authorize the Mission Director, State Health Society / Project Director, Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs.16,58,667/- (Rupees Sixteen Lakh Fifty Eight Thousand Six Hundred and Sixty Seven only) under National Health Mission through Treasury mode.

3. The Government, after careful consideration, have decided to accept the proposal of the Mission Director, State Health Society and they accordingly sanction a sum of Rs.16,58,667/- (Rupees Sixteen Lakh Fifty Eight Thousand Six Hundred and Sixty Seven only) being the 75% of Central share of Rs.12,44,000/- (Rupees Twelve Lakh and Forty Four Thousand only) and the 25% of State share of Rs.4,14,667/- (Rupees Four Lakh Fourteen Thousand Six Hundred and Sixty Seven only) as matching grant to the State Health Society, Tamil Nadu for the Creation of Capital Assets for National Programme for Prevention and Control of Deafness under Non Communicable Disease flexipool of National Health Mission for the year 2014-15.
