

Announcement – Construction of Special Hospital for Infectious Diseases quarantine and treatment in Government Hospital for Thoracic Medicine, Thoppur, Madurai – Administrative and Financial sanction – Orders - Issued.

ORDER:-

During the Demand for Health and Family Welfare Department for 2020-2021, the Hon'ble Chief Minister under Tamil Nadu Legislative Assembly Rule 110 has made the following announcement:-

"கொரோனா வைரஸ் காய்ச்சல், பன்றிக் காய்ச்சல், பறவைக் காய்ச்சல், சார்ஸ் போன்ற தொற்று நோய்களைத் தடுக்கவும், கட்டுப்படுத்தவும் மாநில அளவிலான தனிமைபடுத்தப்பட்ட அரசு மருத்துவமனையாக, தாம்பரம் நெஞ்சக நோய் மருத்துவமனையும், முன்று மண்டல அளவிலான தனிமைப்படுத்தப்பட்ட மருத்துவமனைகளாக, மதுரை மாவட்டம், தோப்பூரில் உள்ள அரசு காசநோய் மருத்துவமனையும், கோயம்புத்தூர் அரசு மருத்துவக் கல்லூரி மருத்துவமனையும் மற்றும் தஞ்சாவூர் மாவட்டம், செங்கிபட்டியில் உள்ள மகாத்மா காந்தி நினைவு காசநோய் சானடோரியம் ஆகிய மருத்துவமனைகளும், சென்னை கிண்டி கிங் நோய் தடுப்பு மருந்து நிலையத்திலுள்ள ஆய்வகத்தை Bio Safety Level — III நிலைக்கு மேம்படுத்துவதற்கும் 110 கோடி ரூபாய் செலவிடப்படும்."

- 2. The Director of Medical Education in his letter read above has forwarded the rough cost estimate prepared by the Engineer in Chief (Buildings), and Chief Engineer (Buildings), Public Works Department, Chennai, duly countersigned by him for a sum of Rs.4013.55 lakh for construction of Hospital for Thoracic Medicine Thoppur Government T.B Hospital in Madurai District.
- 3. The Director of Medical Education has therefore requested the Government to accord administrative and Financial sanction for a sum of Rs.4013.55 lakh for construction of Special Hospital for Infectious Diseases quarantine and treatment and equipment in Government Hospital for Thoracic Medicine, Thoppur, Madurai.

- 4. The Government have examined the proposal of the Director of Medical Education in detail. Accordingly, the Government accord administrative and financial sanction for a sum of Rs.12,00,00,000/- (Rupees Twelve crore only) [Rs. 10.00 crore for building and Rs.2.00 crore for equipment] for construction of Special Hospital for Infectious Diseases quarantine and treatment and purchase of Equipment in Government Hospital for Thoracic Medicine, Thoppur, Madurai. The details of equipments and its approximate cost are mentioned in annexure to this order.
- 5. The amount sanctioned in para 4 above shall be debited to the following Head of Account:-

(i). "4210 – Capital Out lay on Medical and Public Health – 01 – Urban Health Services – 110 – Hospital and Dispensaries (including Pharmacy) – State's Expenditure – JA Building – 416 – Major Works – 01 Major Works".

- 6. The Director of Medical Education is directed that the amount sanctioned for equipments shall not be paid in cash but credited to the following P.D. Account of Tamil Nadu Medical Services Corporation Limited.

7. The expenditure of sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Building) / Director of Medical Education is directed to calculate the actual amount required for the

period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Chief Engineer (Building) / Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2020-2021 to Finance (BG.I / Health-II) Department at the appropriate time without fail.

8. This order issues with the concurrence of Finance Department, vide its U.O.No.115/Health-II/2021, dated 25.01.2021 and ASL No. 1516 (One thousand five hundred and sixteen) dated 24.01.2021.
