From the Director of Medical Education letter Ref.No.79231/P&D II (I)/ 2013, dated 08.01.2014, 07.02.2014 and 21.05.2014.

ORDER:

The Director of Medical Education has requested the Government for creation of 151 posts of various categories to KAP Viswanatham Government Medical college, Trichy towards the increase of number of MBBS seats from 100 to 150.

2. The Director of Medical Education has stated that the proposal received from the Dean, KAP Viswanatham Government Medical College, Trichy has been verified with Medical Council of India norms. He has requested the Government to accord necessary administrative and financial sanction for the creation of posts to KAP Viswanatham Government Medical College, Trichy.

3. The Government, after careful examination of the proposal of the Director of Medical Education, accord sanction for creation of fifty seven posts to KAP Viswanatham Government Medical College, Trichy as detailed below, on a permanent basis, at an approximate cost of Rs. 2.98 crore (Rupees Two Crore and Ninety Eighty Lakhs only) per annum:-

4. The expenditure towards pay and allowances of posts sanctioned in para 3 above shall be debited to the following head of account:-

5. The expenditure sanctioned in para 3 above shall constitute an item of “New Instrument of Service” and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund, orders regarding which will be issued by Finance (BG-I) Department. The Director of Medical Education is directed to send an application in the prescribed form along with the copy of this order to Finance (BG-I) Department, for sanctioning the advance for required quantum. The Director of Medical Education is also directed to send necessary note for inclusion of the expenditure in the Supplementary Estimate 2014-2015 to Finance (BG-I / Health-II) Department at the appropriate time without fail.
