ORDER:

In the letter read above, the Mission Director, National Health Mission has stated that in order to strengthen the Trauma Care Centers (Emergency Services and Triage), a detailed proposal had been included in PIP 2017-18 and it was approved in Record of Proceedings 2017-18 with funds for constructions of operation the area for level and level III Trauma Care Contract as consided below:-

1. Level II Centers (Perambalur, Tiruppur and Ramnad Districts)

Rs. 400.00 lakh

Level III Centers
 (Cheyyar, Ulunthurpet, Rajapalayam, Tiruttani, Attur and Karaikudi)

Rs. 216.00 Lakh

Rs. 616.00 Lakh

2. However, considering the available infrastructure for Trauma Care Centers in the above detailed places, it has been decided to provide Trauma Care Centers at the total cost as noted against each of them in the following 4 places only.

3.In this regard, a detailed agenda vide No.28 had been placed in 34th Executive Committee meeting held on 24.01.2018, seeking permission for reallocation of funds and the agenda was approved.

- 4. The funds Rs. 616 lakhs now reallocated have been remitted through Chellan into Government Account as per the directions issued in G.O(Ms) No.116, Health and Family Welfare (EAP II 2) department, dated 25.03.2011, for the execution of civil works through Public Works Department, required for provision of Trauma Care Centres in the above detailed 4 Government Hospitals.
- 5. The Mission Director, National Health Mission has requested orders in this regard.
- 6. The Government after careful examination has decided to accept the proposal of the Mission Director, National Health Mission and issue following orders,
 - i. Administrative sanction is accorded to execute the following civil works through Public Works Department at a total cost of Rs. 616 lakhs (Rupees Six hundred and sixteen lakhs only) for providing the Trauma Care Centers in the following 4 Government Hospitals, at the total cost as noted against each of them.
