**ORDER:**

The Director of Medical Education has sent the proposal for creation of 53 posts of various categories to Government Mohan Kumaramangalam Medical College, Salem towards the increase of number of MBBS seats from 75 to 100.

2. The Director of Medical Education has stated that the proposal received from the Dean, Government Mohan Kumaramangalam Medical College, Salem has been verified with Medical Council of India norms. He has requested the Government to accord necessary administrative and financial sanction for the creation of posts to Government Mohan Kumaramangalam Medical College, Salem.

3. The Government, after careful examination of the proposal of the Director of Medical Education, accord sanction for creation of seven posts to Government Mohan Kumaramangalam Medical College, Salem as detailed below, on a permanent basis, at an immediate cost of Rs. 42.08 lakhs per annum (Rupees Forty Two Lakhs and Eight Thousand only):-

4. The expenditure towards pay and allowances of posts sanctioned in para 3 above shall be debited to the following head of account:-

5. The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will be initially met by an advance from the Contingency Fund, orders regarding which will be issued by Finance (BG-I) Department. The Director of Medical Education is directed to send an application in the prescribed form along with the copy of this order to Finance (BG-I) Department, for sanctioning the advance for required quantum. The Director of Medical Education is also directed to send necessary note for inclusion of the expenditure in the Supplementary Estimate 2014-2015 to Finance (BG-I / Health-II) Department at an appropriate time without fail.
