## **ORDER:**

In order to cope with the increased demand for Maternity and Child Health services in the Medical College Hospitals, it has become necessary to upgrade the existing infrastructure facilities in Medical College. Besides, the CEmONC centres in Government Medical College Hospitals provide various skill trainings like Life Saving Anesthesia Skill training, EmONC training, SBA training and other skill trainings for doctors and nurses in addition to Maternity and Child Health Services.

2.Considering the necessity it has been proposed to upgrade the existing CEmulas Center in the rollowing 4 Medical Center Hospitals with provision of additional buildings, equipment and furniture at the total cost of Rs.1200 lakh (Rs.1050 lakh for civil works and Rs.150 lakh for equipments and furniture for each hospital)

- 3. The above proposal has been included in PIP 2018-19, for upgrading the CEmONC Centers of 4 Government Medical College Hospitals mentioned above, with a total budgetary requirement of Rs. 4800 lakh. The proposal is approved in Records of Proceedings by the Government of India, for upgrading the CEmONC Centers at a total cost of Rs.4800 lakh for both Civil Works, equipment including furniture, for 4 Government Medical College Hospitals with budgetary provision of fund Rs.480 lakh, for the year 2018-19 i.e at 10% of the total requirement.
- 4. In this regard, additional buildings at a total cost of Rs.1050 lakh through Public Works Department and equipment and furniture at total cost of Rs 150 lakh through Tamil Nadu Medical Services Corporation are to be provided to each of

4 Government Medical College Hospitals, for upgradation of CEmONC Centers. The cost details are as follows:

The balance of funds required in this regard has to be proposed in the subsequent PIPs.

- 5. In this regard, the above proposal has been approved by the Executive Committee in the 35<sup>th</sup> Executive Committee Meeting held on 16.05.2018
- 6. The fund Rs.480 lakh approved for the year 2018-19, for upgradation of CEmONC Centers in Government Medical College Hospitals as detailed above for civil works, has been remitted into Government Account as per the directions issued in G.O(Ms) No.116, H&FW (EAP II -2) dept, dated 25.03.2011, for the execution of works through Public Works Department.

- 8. The Government after careful consideration decided to accept the proposal of the Mission Director, National Health Mission and accordingly order as follows:
  - i. Administrative sanction is accorded to upgrade the CEmONC Centers in the following four Government Medical College Hospitals at a cost of Rs.4200 lakh (Four thousand two hundred lakh) for civil works and Rs.600 lakh (Six hundred lakh) for equipments and furniture. The cost allocation details is as follows:

- ii. Sanction is accorded for a sum of Rs. 4.80 crore (Rupees Four crore and eighty lakh only) for executing the above civil works through Public Works Department at 10% of the total requirement of Rs.4800 lakh (Four thousand eight hundred lakhs) approved.
- iii. The Engineer-in-Chief and Chief Engineer (Buildings) Public Works Department, Chepauk, Chennai is permitted to issue orders to the Executive Engineers of the concerned divisions.
- iv. The Mission Director, State Health Society Tamil Nadu, Chennai is permitted to remit the balance of funds as and when the funds are approved by Government of India.
- 9. The amount sanctioned in para 8 (ii) above shall be debited to the following Head of account.

"4211-00 capital outlay on family welfare-103 Maternity and Child Health — State's Expenditure — AA Civil Works under National Health Mission Scheme — 16 Major works".
