

#### **ABSTRACT**

Establishment – IRT – Perundurai Medical College and Hospital and IRT-School of Nursing run by the Institute of Road Transport - Taken over by the Government of Tamil Nadu in the Health and Family Welfare Department with the existing posts – Opening of new Heads of Account – Fund for a sum of Rs.26,54,76,000/- for salary item for IRT–Perundurai Medical College and Hospital and IRT-School of Nursing for the period from the months April 2019 to December 2019 – Sanctioned - Orders – Issued.

ORDER:

In the Government Order first read above, the Government have taken a policy decision to hand over IRT-Perundurai Medical College and Hospital and IRT – School of Nursing run by the Institute of Road Transport to Government in the Health and Family Welfare Department under the control of the Directorate of Medical Education. Based on the above orders, the Health and Family Welfare Department have taken over all the movable and immovable properties of the said college on record and orders have been issued to this effect vide Government Order second read above.

2. The Director of Medical Education has requested to sanction totally a sum of Rs.35.14 crore for salary and non-salary items as a special case to IRT – Perundurai Medical College and Hospital and IRT – School of Nursing, Perundurai, Erode District, in order to run the Medical College smoothly without any interruption of service and he has also requested to sanction budget allotment for salary as per 6<sup>th</sup> Pay Commission recommendation and to fix salary as per 7<sup>th</sup> Pay Commission recommendation with arrear after issuing Government Order for creation of manpower for the said IRT – Perundurai Medical College and Hospital and IRT – School of Nursing, Perundurai, Erode District.

- 3. The Government have examined the proposal of the Director of Medical Education in detail and found that though the Government in Health and Family Welfare Department have taken over the IRT-Perundurai Medical College and Hospital and IRT - School of Nursing under control of the Directorate of Medical Education, no budget has been made during the current financial year 2019 - 2020. Hence, the employees of the above said college have suffered to get their salary and therefore, they get their salary from the management of Institute of Road Transport. The Government have further examined in detail for the creation of required posts to the said Institution as per Medical Council of India norms is under Hence, the Government have decided to sanction a sum of Rs.26.54.76.000/- (Rupees Twenty Six Crore Fifty Four Lakh and Seventy Six Thousand Only) for salary items for the period from the months of April 2019 to December 2019 for running IRT-Perundurai Medical College and Hospital and IRT-School of Nursing, Perundurai, Erode District by direct inclusion of Final Supplementary Estimates for the year 2019 - 2020 and the break-up details of amount sanctioned for the above said Medical Institutions for the period from the months of April 2019 to December 2019 is annexed to this order.
- 4. The expenditure sanctioned in para 3 above shall be debited to following Heads of Account [Demand No.19 03]:-
