**ORDER:**

In the Government Order first read above, the Government have accorded administrative and financial sanction for a sum of Rs.1,00,00,000/- for the construction of Nursing School Students Hostel at Ramanathapuram.

2. The Director of Medical Education, in her letter second read above, has forwarded the revised proposal for sanction of a sum of Rs. 1,10,00,000/- received from the Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai for the construction of Hostel building for the School of Nursing at Ramanathapuram, against the original administrative and financial sanction of Rs. 1,00,00,000/-.

3. The Engineer-in-Chief and Chief Engineer (Buildings), Public Works Department, Chennai has stated that amount for the construction of Hostel building for the School of Nursing, Ramanathapuram works out to Rs. 1,10,00,000/- and the details towards tender excess and other charges are as follows:-

The proposal has been cleared by Technical Advisory Committee constituted in G.O.(Ms) No.146, Public Works Department, dated: 12.08.2011 to scrutinize the revised administrative sanction proposal in respect of all technical and financial aspects involved in the work and the Tender Award Committee in its 195<sup>th</sup> meeting on 23.01.2014 has approved the revised administrative sanction proposal for a sum of Rs. 1,10,00,000/- for the construction of Hostel building for the School of Nursing at Ramanathapuram against the original administrative and financial sanction of Rs. 1,00,00,000/- with an instruction that there should not be any further revised administrative sanction and subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Public Works Department, Madurai.

5. The Government have examined the above proposal of the Director of Medical Education and decided to accept the same. Accordingly, revised administrative and financial sanction is accorded for a sum of Rs. 1,10,00,000/- (Rupees One Crore and Ten Lakhs only) for the construction of Hostel building for the School of Nursing at Ramanathapuram as against the original administrative and financial sanction of Rs.1,00,00,000/-.(Rupees One Crore only)

6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-

"4210-Capital Outlay on Medical and Public Health-01 Urban Health Services-110- Hospitals and Dispensaries (including Pharmacy) - Schemes in the Twelfth Five Year Plan-II- State Plan JA- Buildings-16 Major works."

7. Necessary additional funds will be provided in Revised Estimate / Final Modified Appropriation 2014-2015. Pending provision of funds in the Revised Estimate 2014-2015, the Chief Engineer (Buildings) is authorized to draw disburse the amount sanctioned in para 5 above. The Chief Engineer (Buildings) is requested to include the expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2014-2015 to Government in Finance (Health-II) Department without fail.
