ORDER:

In the circumstances reported by the Director of Medical and Rural Health Services in his letter third read above, the Government accord sanction for revival and further continuance of one temporary post of Health Visitor at Government Hospital, Pattukkottai, Thanjavur District which was originally sanctioned in Government order first read above and last continued upto 30.06.1999 in Government Order second read above, for the period from the date of filling up of the posts i.e., from 23.08.2010 upto 30.04.2013 or till the need therefor ceases whichever is earlier.

2. The holder of the post is eligible to draw besides pay in the time scale of pay Rs.9300-34800 with Grade Pay of Rs.4200/- Dearness Allowance / House Rent Allowance and other allowances admissible as per the orders and the rules in force and subsequent orders issued from time to time.


