ORDER:

The Director of Medical Education in her letter read above, has sent the proposal for construction of additional buildings for Resident's Quarters (Male and Female) in Government Medical College, Sivagangai. She has stated that as per the Medical Council of India norms, quarters is required for 85 Resident's accommodation. But the available Resident's Quarters with G+3 floors is only for 60 Residents. Hence, quarters are required for 25 Residents.

- 2. The Director of Medical Education has countersigned and forwarded the Rough Cost Estimate prepared by the Engineer in Chief and Chief Engineer (Buildings), Chennai Region and Chief Engineer (General), Public Works Department, Chennai, in the schedule of rates for the year 2014-2015 and the amount works out to Rs. 113.30 lakhs
- 3. The Government, after careful examination, have decided to accept the proposal of the Director of Medical Education. Accordingly, the Government sanction a sum of Rs. 113.30 lakhs (Rupees One Crore Thirteen Lakhs and Thirty Thousand only) for the construction of additional buildings for Resident's Quarters (Male 14 Nos and Female 14 Nos) totally 28 numbers of Resident's Quarters in Government Medical College at Sivagangai District for the year 2014-2015.
- 4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

"4210 – Capital Outlay on Medical and Public Health – 01 Urban Health Services – 110 Hospitals and Dispensaries (including Pharmacy) – Schemes in the Twelfth Five Year Plan-II – State Plan – JA- Buildings - 16 Major Works"

- 5. The expenditure sanctioned in para 3 above shall constitute an item of "New instrument of Service" and the approval of the legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of an advance from the Contingency Fund will be issued by the Finance (BG-I) Department. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund in the prescribed format along with a copy of this order for the required amount to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory note to include the above expenditure in the supplementary estimate for the year 2014-2015 to Finance (Health-II /BG-I) Department at the appropriate time without fail.
- 6. This order issues with the concurrence of Finance Department vide its U.O No.54300/Health-II/2014, dated: 16.10.2014 and ASL No. 1326 [One thousand three hundred and twenty six]
