

ABSTRACT

Medical Education – Starting of New Government Medical College at Pudukottai District from the academic year 2017-2018 and creation of one post of Special Officer-cum-Dean – Orders – Issued.

ORDER:

During the Budget discussion held in the Tamil Nadu Legislative Assembly 2015-2016, the Hon'ble Chief Minister has announced, among others, that a Government Medical College will be established at Pudukottai District.

- 2. The Government, after considering the growing demand of meritorious students of the State for Professional Medical Courses, have decided to start a new Government Medical College at Pudukottai District from the academic year 2017-2018.
 - 3. The Government accordingly issue the following orders:
 - (i) A new Government Medical College shall be established at Pudukottai District with an annual intake of 150 students from the academic year 2017-2018.
 - (ii) Sanction is accorded for creation of one post of Special Officer-cum-Dean in the scale of pay of Rs.37,400-67,000+8,800, Grade Pay to attend the initial work relating to the establishment of a new Government Medical College at Pudukottai District for a period of one year from the date of employment. The holder of the post is eligible to draw Dearness Allowance, House Rent Allowance and other allowances applicable as per rules.
 - (iii) Orders in respect of land, building, hospital equipments, furniture and staff, etc. will be issued separately on receipt of the report of the Director of Medical Education.
- 4. The Director of Medical Education is directed to send proposal for issue of Essentiality Certificate, application and time bound action programme to Government immediately so as to send to the Government of India / Medical Council of India within due date for starting new Government Medical College at Pudukottai District from the academic year 2017-2018.
- 5. The Director of Medical Education is also directed to take appropriate action to assess the requirements of necessary infrastructure such as land, building, equipments, furniture, staff, etc., and send necessary proposal to the Government at the earliest.
- 6. The expenditure in respect of the post sanctioned in para 3(ii) above shall be debited under the following New Head of Account opened under Demand No.19-03

"2210 Medical and Public Health 05 – Medical Education, Training and Research 105 Allopathy – I Non-Plan BX - Government Medical College, Pudukottai – 01 – Salaries."

- 7. The Director of Medical Education is the estimating, reconciling and controlling authority for the above said new Head of Account.
- 8. The Pay and Accounts Officer / Treasury Officer is directed to open the above new Head of Account in their books.
- 9. The expenditure sanctioned in para 3 (ii) above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical Education is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical Education is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2015-2016 to Finance Department at the appropriate time without fail.
- 10. This order issues with the concurrence of Finance Department vide its U.O. No.60790 / CMPC / 2015, dated 30.10.2015 and ASL No. (1189 (One thousand one hundred and eighty nine)
