ORDER:

In Government Order sixth read above, permission was accorded to the Chairman, Shree Venkateshwara Educational and Charitable Trust, Erode to start four years B.Sc (Nursing) course with an annual intake of 60 (sixty) students in the name and style as "Shree Venkateshwara College of Nursing" in S.F.No.1224/6B, Othakuthirai, Kugaloor Village, Gobichettipalayam Taluk, Erode District from the academic year 2019-2020.

- 2. The Chairman, Shree Venkateshwara Educational and Charitable Trust, Othakuthirai, K. Mettupalayam Post, Gobi, Erode District has requested the Government to grant permission to enhance the seats in B.Sc (Nursing) course from 60 to 100 from the academic year 2020-2021 at Shree Venkateshwara College of Nursing, Othakuthirai, K. Mettupalayam Post, Gobi, Erode District.
- 3. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to fifth read above and the Indian Nursing Council, New Delhi.
- 4. In his letter eighth read above, the Director of Medical Education has submitted the proposal wherein he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to give permission to the Chairman, Shree. Venkateshwara Educational and Charitable Trust, Othakuthirai, K. Mettupalayam Post, Gobi, Erode District to enhance the seats in B.Sc (Nursing) course from 60 to 100 from the academic year 2020-2021 at Shree Venkateshwara College of Nursing, Othakuthirai, K. Mettupalayam Post, Gobi, Erode District.
- 5. The Government have examined the case in detail in the light of the Inspection Report and the recommendations of the Director of Medical Education and grant permission to the Chairman, Shree Venkateshwara Educational and Charitable Trust, Othakuthirai, K. Mettupalayam Post, Gobi, Erode District to enhance the seats in B.Sc Nursing course from 60 to 100 (sixty to hundred) at Shree Venkateshwara College of Nursing in Survey.Nos.1224/6B, 1223/4B and 1218/3, Othakuthirai, K. Mettupalayam Post, Gobi, Erode District 638 455 from the academic year 2020-2021, subject to the following conditions before admitting the students:
 - a) Admission of students shall be made as per the rules fixed by the Government from time to time.
 - b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.

- c) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.
- d) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- e) As per the INC norms, the Trust should construct its own 150 bedded hospital for the proposed nursing college.
- f) The Trust should obtain recognition / affiliation from the Tamil Nadu Nurses and Midwives Council, Chennai and the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively.
- 6. The Director of Medical Education is directed to take necessary further action accordingly.
