### ORDER:

The Director of Medical Education has sent proposal for construction of School of Nursing and Hostel building for 200 students at Government Thoothukudi Medical College, Thoothukudi. The Director of Medical Education has further stated that only one building is available for Nursing School with a capacity of 50 students and no hostel building is available. At present, 220 students are staying in the staff nurses quarters where 10 to 15 students are sharing one room. Hence, he has proposed construction of Nursing School building on a total plinth area of 2941.00 sq.m with Ground+1 floor and Nursing Hostel building on a total plinth area of 2880.10 sq.m.

2. The Director of Medical Education has countersigned and forwarded the Rough Cost Estimate prepared by the Chief Engineer (Buildings), Public Works Department, Madurai Region, in the schedule of rates for the year 2014-2015 and the amount works out to Rs. 11.70 crore.

3. After careful examination of the proposal of the Director of Medical Education, the Government accord administrative and financial sanction for a sum of Rs.11.70 (Rupees Eleven Crore and Seventy Lakhs only) for the construction of School of Nursing and Hostel building for 200 students in Government Medical College at Thoothukudi as detailed in the annexure.

4. The expenditure sanctioned in para 3 above shall be debited to the following Head of account:-

“4210-Capital Outlay on Medical and Public Health-01 Urban Health Services-110-Hospitals and Dispensaries (including Pharmacy)- Schemes in the Twelfth Five Year Plan-II- State Plan-JA- Buildings16- Major Works. (DPC 4210-01-110-JA-1602)”

5. The expenditure sanctioned in para 3 above shall constitute an item of "New instrument of Service" and the approval of the legislature will be obtained in due course. Pending approval of the legislature, the expenditure will be initially met by drawal of an advance from the Contingency Fund. Orders for sanction an advance from the Contingency Fund will be issued by the Finance (BG-I) Department separately. The Chief Engineer (Buildings) shall apply for sanction of advance from Contingency Fund in the prescribed format along with a copy of this order for the required amount to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory note to include the above expenditure in the supplementary estimate for the year 2014-2015 to Finance (BG-II / Health-II) Department at the appropriate time without fail.

6. This order issues with the concurrence of Finance Department vide its U.O. No.54331/ Health-II/2014, dated 16.10.2014 and ASL No. 1343 (One thousand three hundred and forty three).
