ORDER :

In the Government order first read above, the Government have accorded Administrative and Financial sanction for a sum of Rs.19,65,00,000/- towards construction of building for Rheumatology Department at Rajiv Gandhi Government General Hospital, Chennai.

2. In his letter second read above, the Director of Medical Education has forwarded the Revised Administrative Sanction for a sum of Rs.23,12,31,350/- received from the Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chennai towards the construction of building for Rheumatology Department at Rajiv Gandhi Government General Hospital, Chennai and he has requested the Government to accord Revised Administrative and Financial Sanction for a sum of Rs.23,12,31,350/- against the original administrative sanction of Rs.19,65,00,000/-.

3. The Tender Award Committee, in its 272nd meeting held on 14.11.2017, has approved the Revised Administrative Sanction proposal for a sum of Rs.23,12,31,350/- towards the construction of building for Rheumatology Department at Rajiv Gandhi Government General Hospital, Chennai, against the original administrative sanction of Rs.19,65,00,000/- with an instruction that there should not be any further Revised Administrative Sanction and the decision arrived at by the Committee are subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Chennai.

4. The Government after careful examination of the proposal of the Director of Medical Education in detail and decided to accept the same. Accordingly, the Government accord Revised Administrative and Financial sanction for a sum of

Rs.23,12,31,350/- (Rupees Twenty Three Crore Twelve lakh Thirty One Thousand and Three Hundred Fifty only), an additional amount of Rs.3,47,31,350/- (Rupees Three Crore Forty Seven Lakhs Thirty One Thousand and Three Hundred and Fifty only) is sanctioned over and above the original administrative sanction of Rs.19,65,00,000/- for the construction of building for Rheumatology Department at Rajiv Gandhi Government General Hospital, Chennai, with a condition that there should not be any further Revised Administrative Sanction.

5. The expenditure sanctioned in para 4 above shall be debited to the following head of account:-

"4210. - Capital Outlay on Medical and Public Health – 01.Urban Health Services – 110. Hospitals and Dispensaries (Including Pharmacy) - State's Expenditure – JA. Buildings – 416. Major Works 01 Major workds (D.P.C 4210-01-110-JA-1602 – Old IFHRMS (D.P.C 4210-01-110-JA-41601)".

6. The amount sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings), Public Works Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG.I) Department directly, in Form-A appended to the Tamil Nadu Contingency Fund Rules, 1963, along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG.I) Department. The Chief Engineer (Buildings), Public Works Department is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2019-2020 to the Finance (BG.I) Department at the appropriate time without fail.

7. This order issues with the concurrence of the Finance Department vide its U.O.No.34167/Health-II/2019, dated 30.07.2017 and ASL No.836 (Eight Hundred and Thirty Six).
