ORDER:

In Government Order third read above, permission was accorded to the President, Tamil Nadu Muslim Women Education and Welfare Association, Dharapuram, Periyar District (Now Tirupur District) to start B.Sc (Nursing) Degree course in the name and style of "Sara Nursing College" with an annual intake of 50 seats from the academic year 1993-1994.

2. The Principal, Sara Nursing College, Dharapuram has requested the Government to grant permission for change of site from Karur Main Road, Dharapuram to Palani Main Road, Manakadavu, Dharapuram, Tirupur District.

3. In Government letter seventh read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first and second read above and fourth to sixth read above and the Indian Nursing Council, New Delhi.

4. In his letter eighth read above, the Director of Medical Education has submitted the proposal wherein he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to give permission to the Principal, Sara Nursing College, Dharapuram for change of site from Karur Main Road, Dharapuram to Palani Main Road, Manakadavu, Dharapuram, Tirupur District.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Principal, Sara Nursing College, Dharapuram run by Tamil Nadu Muslim Women Education and Welfare Association, Dharapuram Taluk, Tirupur District for change of site from Karur Main Road, Dharapuram to Palani Main Road, Manakadavu, Dharapuram, Tirupur District in Sara Nursing College in S.F. No.703, Manakkadavu Village and Panchayat, Dharapuram Taluk, Tirupur District – 638 673 from the academic year 2020-2021, subject to the following conditions before admitting the students:-

- a) Admission of students shall be made as per the rules fixed by the Government from time to time.
- b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.
- c) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of

rules and regulations of the Government by the Trust like winding of course without valid reasons etc.

- d) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- e) The institution should obtain building plan approval from the DTCP for the new site, before admitting the students.
- f) As per the INC norms, the Institution should construct its 100 bedded own hospital with in a period of 3 years.

6. The Director of Medical Education is directed to take necessary further action accordingly.
