ORDER:

The Hon'ble Minister for Health has made an announcement among others in the floor of the Legislative Assembly during the Budget session for year 2014-2015, that 1200 Numbers of Non-Pneumatic Anti-Shock Garments would be provided at a cost of Rs.60 Lakhs out of the insurance receipts of Government Hospitals.

- 2. The Director of Public Health and Preventive Medicine has stated that the Non-Pneumatic Anti Shock Garment is a lightweight, washable and reusable garment made of Neoprene and Velcro applied in 6 simple steps by any trained caregiver. This Garment can be used in all geographic locations and in all cases of postpartum hypovolemic shock. It is a life saving innovative intervention used for controlling postpartum bleeding. Application of Non-pneumatic Anti Shock Garment (NASG) by trained caregivers to women suffering from hypovolemic shock reverses and stablises bleeding until the women reach a health facility where they can be effectively managed. It reduces further blood loss and is used to transport patients to a tertiary center or district hospital where surgical expertise and blood are available to control and manage bleeding. It is also used in tertiary hospitals to stablise women in shock till arrangements for blood and surgery are made. Provision of NASG will be helpful in reducing maternal mortality and morbidity can be controlled at all levels by supplying adequate numbers of Non-pneumatic Anti Shock Garments to all Government Health Facilities and 108 Ambulances.
- 3. The Director of Public Health and Preventive Medicine has further stated that the major cause of the maternal death is due to (PPH) post partum hemorrhage.

use of Non-pneumatic Anti Shock Garments is very essential to reduce maternal deaths occuring due to (PPH) post partum hemorrhage. It is also essential during inter facility transfer of Post Natal mothers.

- 4. In order to implement the announcement the Director of Public Health and Preventive Medicine has requested the Government to accord necessary permission and administrative and financial sanction for a sum of Rs.60,00,000/- (Rupees Sixty Lakhs only) for the year 2014-2015 the Project Director, Tamil Nadu Health System Project to procure 1200 Non-pneumatic Anti Shock Garments from the insurance receipts either through direct procurement from M/s Vissco Rehabilitation Aids Pvt Ltd, Mumbai or through Tamil Nadu Medical Services Corporation by including in CPC list of items and supply the same to the O/o The Director of Public Health and Preventive Medicine, so as to enable him to distribute the same to all the Government Health facilities as envisaged in the above announcement.
- 5. The Government have examined the proposal of the Director of Public Health and Preventive Medicine in detail and accord administrative and financial sanction for a sum of Rs.60 lakhs (Rupees Sixty lakhs only) for procurement of 1200 Non-Pneumatic Anti Shock Garments at a cost of Rs.60 lakhs from the insurance receipts of Government Hospitals and to permit the Tamil Nadu Medical Services Corporation for the above procurement by following the Tamil Nadu Transparency in Tenders Act.
- 6. This order issues with the concurrence of the Finance Department vide its U.O.No. 5188/Health-I/2015, dated 29.01.2015.
