ORDER:

In the Government order first read above, the Government have sanctioned Rs.58.65 crore for the construction of building for Out patients and other departments at Rajiv Gandhi Government Hospital, Chennai. In the letters second read above, the Director of Medical Education has stated that the above construction work consists of basement + Ground + 4 floors only. This work has been structurally completed upto Basement + Ground floor + Four floors and the building is expected to be completed by February' 2018. This outpatient block is expected to cater the needs of, roughly about 15,000 patients daily for various ailments and the same will increase every year. Hence, this building was designed to accommodate basement floor + ground floor + 8 floors, ultimately. To cater the rising needs and also to accommodate more departments, the Director of Medical Education has forwarded the rough cost estimate prepared by the Chief Engineer (Buildings) duly countersigned by him for the construction of 5th floor to 8th floor over the 4th floor of Outpatient Block at Rajiv Gandhi Government Hospital, Chennai, with the following provisions:-

2. The Director of Medical Education has, therefore, requested the Government to issue necessary administrative and financial sanction for the construction of 5th floor to 8th floor over the 4th floor of Outpatient Block at Rajiv Gandhi Government Hospital, Chennai at a cost of Rs.40.30 crores for the year 2015-16.

3. The Government after careful examination of the proposal of the Director of Medical Education in detail and accord administrative sanction for a sum of Rs.42.88 crore (Rupees Forty Two crore and Eighty Eight lakhs only) for the construction of 5th floor to 8th floor over the 4th floor of Outpatient Block at Rajiv Gandhi Government Hospital, Chennai and financial sanction for a sum of Rs.24.00 crore (Rupees Twenty Four crore only) for the year 2017- 2018.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

“4210.Capital Outlay on Medical and Public Health – 01.Urban Health Services – 110. Hospitals and Dispensaries (Including Pharmacy) - State’s Expenditure – JA. Buildings – 16. Major Works (D.P.C 4210-01-110-JA-1602)”.

5. The expenditure sanctioned in para 3 above shall constitute an item of “New Instrument of Service” and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings), Public Works Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG.I) Department directly, in Form A appended to the Tamil Nadu Contingency Fund Rules, 1963, along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG.I) Department. The Chief Engineer (Buildings), Public Works Department is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2017-2018 to the Finance (BG.I) Department at the appropriate time without fail.

6. This order issues with the concurrence of the Finance Department vide its U.O.No.361/Health-II/2018, dated: 25.01.2018 and ASL No.2559 (Two thousand five hundred and fifty nine).
