ORDER:

In G.O. first read above, a sum of Rs.5.00 crore has been sanctioned towards the Government's contribution to the Tamil Nadu Trust for children affected by HIV/AIDS (TNTCAA).

2. In G.O. second read above, orders have been issued to providing additional financial assistance of Rs. 5.00 crore (Rupees five crore only) in addition to the existing corpus fund to the Orphaned and Vulnerable Children Trust for Children affected and infected by HIV/AIDS and to deposit in the above said amount in the Power Finance Corporation along with the old corpus fund, which will be used for benefiting approximately 1000 more children infected and affected by HIV/AIDS and that the principles mentioned in the operational guidelines of the Trust has to be followed by the Project Director, Tamil Nadu State AIDS Control Society and the trust will grant for children based on their age and educational level as detailed below:-

- 3. The Project Director, Tamil Nadu State AIDS Control Society in his letter 3rd read above has sated that Tamil Nadu State AIDS Control Society receives nearly 10,500 applications (both from infected/ affected children) from all the 32 districts of the State through the respective District evel AIDS Prevention and Control Units (DAPCUs), out of which only 3594 (34%) children have been annually supported and benefited from the accrued deposited interest amount during the Financial year (2017-2018). The provision of Annual financial support is very minimal. (i.e) ranging from 2000/- to 3000/- to each of the HIV infected/affected Child. In this financial year (2018-2019), in order to up-scale and cover more number of needy Children living with and affected by HIV/AIDS under the Tamil Nadu Trust for Children Affected by AIDS (TNTCAA) scheme, an O.V.C data enumeration process has been carried out at the district level through the District level AIDS Prevention and control units (DAPCUs) so as to extend financial support to the children who are undergoing Higher Education under various Professional courses namely UG/PG Colleges, Diploma/Polytechnic courses etc @ Rs. 5000/each for their Education & Nutritional supplements. Hence, there is a need to increase the number of children beneficiaries and units; the corpus to TNTCAA Trust needs to be increased to Rs.20 crore.
- 4. The Project Director, Tamil Nadu State AIDS Control Society has stated that to increase the financial assistance an additional corpus fund of Rs.10.5 crore is needed to the existing 9.5 crore to meet out the remaining O.V.C children for their Higher Education & Nutritional Supplements. The Trust (TNTCAA) will grant for these children based on their age and educational level as per the operational guidelines. The number of O.V.C children beneficiaries, who have been supported during the past nine years (i.e) since from the commencement of this scheme, is as follows:-

- 5. The Project Director, Tamil Nadu State AIDS Control Society has therefore requested to Government for an Additional corpus fund of Rs.10.5 crore in-order to extend financial support to the remaining HIV infected & affected children in Tamil Nadu, aged from birth until they complete 18 years of age.
- 6. The Government after careful examination of the request of Project Director, Tamil Nadu State AIDS Control Society have decided to accept the same in partial modification and issue the following orders:
 - i) An Additional Corpus Fund of Rs.5.00 crore (Rupees five crore only) is sanctioned to the Tamil Nadu Trust for the Children affected by HIV/AIDS (TNTCAA) (living with & affected by HIV/AIDS) to lead a better life.
 - ii) Project Director, Tamil Nadu State AIDS Control Society is instructed to deposit the amount in Power Finance Corporation along with the old Corpus Fund.
- 7. The amount sanctioned in para 6 (i) above shall be debited to the following Head of Account:-

"2251-00-Secretariat Social Services – 090- Secretariat – State's Expenditure JE Government's contribution to the Trust for Children Orphaned / affected by AIDS – 309 – Grants-in-aid-03-Grants for Specific Scheme" (DPC 2251-00-090-JE 30936)

8. The expenditure sanctioned in para 6 (i) above is an item of "New Instrument of Service". The approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Secretary to Government, Health and Family Welfare Departments is directed to apply for sanction of advance from the Contingency Fund to Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Order for sanction of an advance for the Contingency Fund will be issued from Finance (BG-I) Department. The Secretary to Government, Health and Family Welfare Departments is also requested to send a draft explanatory notes for including the above expenditure in the Supplementary Estimate 2019-2020 to Finance (BG.I/Health-I) Department without fail.

- 9. The Section Officer (Bills), Health and Family Welfare Department is authorized to draw and disburse the amount to the Project Director, Tamil Nadu State AIDS Control Society by means of a Cheque drawn in favour of the Project Director, Tamil Nadu State AIDS Control Society.
