- 4. The Government also appoint them (in Sl. No. 20 to 24 in the list annexed) temporarily as Assistant Medical Officer (Unani) in Tamil Nadu Medical Service, in the Department of Indian Medicine and Homoeopathy subject to the condition that, final orders to be passed by the Hon'ble High Court of Judicature at Madras in W.P.No.20931/2014 alongwith other writ petitions relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of the Madras High Court.
- 5. The candidates appointed temporarily as Assistant Medical Officer (Unani) SI.Nos.20,22,23 and 24 in the approved list, should pass the second class language test (full test) in Tamil within a period of two years from the date of their appointment since they do not possess adequate knowledge in Tamil, failing which they will be discharged from service.
