ORDER:

In the Government order first read above, the Government have accorded Administrative and Financial sanction for a sum of Rs.71,50,00,000/-. towards carrying out the additional works in Towers 1 to 3 of Government Medical College and Hospital in Block 'B' at Omandurar Government Estate, Chennai.

2. In his letter second read above, the Director of Medical Education has forwarded the Revised Administrative Sanction proposal for a sum of Rs.72,88,30,900/- received from the Engineer in Chief and Chief Engineer (Buildings), Public Works Department, Chennai, towards carrying out the additional works in Tower 1 to 3 of Government Medical College and Hospital in Block 'B' at Omandurar Government Estate, Chennai and he has requested the Government to accord Revised Administrative Sanction for a sum of Rs.72,88,30,900/- against the original administrative sanction of Rs.71,50,00,000/-. The details of Revised Administrative sanction required is as follows:-

The Tender Award Committee, in its 297th meeting held on 26.11.2018, has approved the Revised Administrative Sanction proposal for a sum of Rs.72,88,30,900/- for carrying out the additional works in Tower 1 to 3 of Government Medical College and Hospital in Block 'B' at Omandurar Government Estate, Chennai, against the original administrative sanction of Rs.71,50,00,000/- with an instruction that there should not be any further Revised Administrative Sanction and the decision arrived at by the Committee are subject to accuracy, correctness and genuineness of all informative data furnished by the Chief Engineer (Buildings), Chennai.
- 4. The Government after careful examination of the proposal of the Director of Medical Education in detail and decided to accept the same. Accordingly, the Government accord Revised Administrative and Financial Sanction for a sum of Rs.72,88,30,900/- (Rupees Seventy Two Crore Eighty Eight Lakh Thirty Thousand and Nine Hundred only) i.e Rs.1,38,30,900/- (Rupees One Crore Thiry Eight Lakhs Thirty Thousand and Nine Hundred only) over and above the Original administrative sanction of Rs.71,50,00,000/- for carrying out the additional works in Towers 1 to 3 of Government Medical College and Hospital in Block 'B' at Omandurar Government Estate, Chennai, with a condition that there should not be any further Revised Administrative Sanction.
- 5. The amount sanctioned in para 4 above shall be debited to the following head of account:-
 - "4210. Capital Outlay on Medical and Public Health 01. Urban Health Services 110. Hospitals and Dispensaries (Including Pharmacy) State's Expenditure JA. Buildings 416. Major Works 01.Major Works (D.P.C. 4210-01-110-JA-41601) IFHRMS (old DPC 4210 -01-110-JA.1602)"
- 6. The amount sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings), Public Works Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG.I) Department directly, in Form-A appended to the Tamil Nadu Contingency Fund Rules, 1963, along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG.I) Department. The Chief Engineer (Buildings), Public Works Department is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2019-2020 to the Finance (BG.I) Department at the appropriate time without fail.
