## ORDER:

In the Government Order first read above, adhoc rules for the temporary post of Health Education Instructor was framed.

In exercise of the powers conferred, by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the rules published with the Health and Family Welfare Department Notification No.B-13/75 at pages 14-15 of Part (III)-Section 1(b) of the Tamil Nadu Government Gazette, dated the 8<sup>th</sup> January 1975, as subsequently amended.

2. The amendment hereby made shall be deemed to have come into force on the 14<sup>th</sup> November 1977.
