

Establishment - Tamil Nadu Public Health Subordinate Service- Fixing the estimate of vacancy for the post of Multi Purpose Health Worker (Male) (Health Inspector Grade –II) – Filling up the post by relaxing the adhoc rule - Orders issued.

ORDER:

In his letters first read above, the Director of Public Health and Preventive Medicine has stated among others that in view of the large vacancies in the post of Multipurpose of Health Worker (Male) (Health Inspector Grade-II) and non-availability of trained candidates as on date, he has requested the Government to issue orders on the following points:-

- Approval for the estimate of vacancy for 1250 posts of Multipurpose of Health Worker (Male) (Health Inspector Grade-II).
- Permission to fill up the above vacancies by relaxing the relevant ii. ad-hoc rule as one time measure.
- Qualifications may be prescribed as below:
 - a. Must have passed plus two with Biology or Botany and Zoology.
 - b. Must have passed Tamil Language as a subject in SSLC level.
 - c. Must possess one year Multi Purpose Health Worker (Male) Course/ Sanitary Inspector Course in University affiliated / Government recognized institutions. The syllabus followed in such institutions should be equivalent to the syllabus prescribed by the Director of Public Health and Preventive Medicine.

- 2. As per the adhoc rules framed for the post of Multipurpose Health Worker (Male) (Health Inspector Grade-II), the educational qualification is prescribed as follows:
 - i) Must have passed plus two with Biology or Botany and Zoology.
 - ii) Must have passed Tamil Language as a subject in S.S.L.C Level.
 - iii) Must possess one year Multipurpose Health Worker (Male) training course certificate granted by the Director of Public Health and Preventive Medicine conducted in the Government Training Centre or Institutions approved by the Director of Public Health and Preventive Medicine.
- 3. In the Government order second read above, the Government have sanctioned the posts of Multi Purpose Health Worker (Male) (Health Inspector Grade II) and Multipurpose Health Supervisor (Health Inspector Grade I) based on the revised norms prescribed therein. The details of the sanctioned posts and men in position are as follows:

Among the sanctioned posts of Multi Purpose Health Worker (Male) (Health Inspector Grade II), it has been identified that total number of 334 posts are kept vacant, since, there is no differentiation in the working nature of these two posts.

- 4. The Government have examined the proposal of the Director of Public Health and Preventive Medicine in detail and decided to permit him to fill up the vacancy of 334 posts Multi Purpose Health Worker (Male) (Health Inspector Grade-II) as identified in the Government Order second read above by giving one time relaxation of the rule 5(b) of adhoc rule for the above said post through the Medical Service Recruitment Board. The Government accordingly do and hereby direct that the Director of Public Health and Preventive Medicine be permitted to fill up the 334 posts of Multi Purpose Health Worker (Male) (Health Inspector Grade-II) which are vacant at present based on the norms fixed in the Government Order second read above by giving one time relaxation of the rule 5(b) of adhoc rule for the above said post through the Medical Service Recruitment Board with the candidates who fulfilled the following qualifications:
 - i. Must have passed plus two with Biology or Botany and Zoology.
 - ii. Must have passed Tamil Language as a subject in SSLC level.

iii. Must possess one year Multi Purpose Health Worker (Male) Course/ Sanitary Inspector Course in University affiliated / Government recognised institutions. The syllabus followed in such institutions should be equivalent to the syllabus prescribed by the Director of Public Health and Preventive Medicine.
