ORDER:

In the Government order first read above, orders have been issued for the constitution of Medical Services Recruitment Board exclusively for Health and Family Welfare Department so as to centralize the mode of direct recruitment to all categories existing in Health and Family Welfare Department except those that are coming under the purview of Tamil Nadu Public Service Commission. In the Government order second read above Rules of Procedure of Medical Services Recruitment Board for recruitment to various categories have been issued.

- 2. Subsequently in the Government order third read above amendment to the method of Recruitment in respect of Assistant Surgeon (General / Dental / Specialty) and Nurses to the above Rules of Procedure have been issued. In the Government order fourth read above amendment in the method of Recruitment to the post of Physiotherapist Grade-II have been issued.
- 3. Now, in his letter fifth read above, the Chairman, Medical Services Recruitment Board (MRB) has sent amendment proposal to the Method of Recruitment to the post of Pharmacist in the Rules of Procedure to be followed.
- 4. The Government have examined in detail the above proposal of the Chairman, Medical Services Recruitment Board (MRB) and has decided to accept it. Accordingly the following amendment to the Method of Recruitment to the post of

Pharmacist is issued to the Rules of Procedure of the Medical Services Recruitment Board 2014:-

Amendment

In the said Rules, for the existing entries in rule 3 (A) (i), the following entries shall be substituted:-

"All Direct recruitment posts in Assistant Surgeon (General), Assistant Surgeon (Dental - General / Speciality), Nurses, Physiotherapist Grade-II and Pharmacist shall be made, through open advertisement (in atleast two newspapers and one of which must be in vernacular language), by conducting written examination (through physical or electronic mode) duly following the procedures prescribed.
