From the Director of Medical Education letter Ref.No.44597/P&D/1/1/2013, dated 30.07.2013, 23.04.2014 and 21.08.2014.

ORDER:

In her letters read above, the Director of Medical Education has sent the proposal for the construction of Nursing students hostel at Coimbatore Medical College Hospital, Coimbatore

- 2. The Director of Medical Education has stated that totally 566 Nursing students are studying and at present 80 hostel rooms are available in Coimbatore Medical College, Coimbatore. As per Indian Nursing Council norms, 188 hostel rooms are required for the 566 students studying in Coimbatore Medical College, Coimbatore. To fulfill the Indian Nursing Council norms, 45 hostel rooms are proposed to be constructed.
- 3. The Director of Medical Education has countersigned and forwarded the rough cost estimate prepared by Chief Engineer (Buildings), Public Works Department, Trichy Region, Trichy, based on the schedule of rates for the year 2014-2015 and requested the Government to accord administrative and financial sanction for the construction of Nursing students hostel at Coimbatore Medical College Hospital, Coimbatore.
- 4. The rough cost estimate for the construction of Nursing students hostel at Coimbatore Medical College Hospital, Coimbatore based on the schedule of rates for the year 2013-2014 is Rs.2,93,97,000/- and the estimate amount works out to Rs.3,23,07,000/- for the year 2014-2015.
- 5. The Government, after careful examination accept the proposal of the Director of Medical Education and accord administrative and financial sanction for a sum of Rs. 3,23,07,000/- (Rupees Three Crore Twenty Three Lakhs and Seven Thousand only) for the construction of Nursing students hostel at Coimbatore Medical College Hospital, Coimbatore, based on the schedule of rates for the year 2014-2015.

- 6. The expenditure sanctioned in para 5 above shall be debited to the following head of account:-
 - "4210 Capital Outlay on Medical and Public Health 01 Urban Health Services 110 Hospitals and Dispensaries (including Pharmacy) Schemes in the Twelfth Five Year Plan- II State Plan JA Buildings 16 Major Works" (D.P.C 4210-01-110-JA-1602)
- 7. The expenditure sanctioned in para 5 above shall constitute on item of "New Instrument of Service" and the approval of legislature will be obtained in due course. Pending approval of legislature, the expenditure will be initially met by an advance from the contingency fund. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department. The Chief Engineer (Buildings) shall apply for sanction of advance from contingency fund for the required amount, in the prescribed format along with a copy of this order to Finance (BG-I) Department. The Chief Engineer (Buildings) shall also send necessary explanatory notes to include the above expenditure in the Supplementary Estimate for the year 2014-2015 to Finance Department at the appropriate time without fail.
- 8. This order issues with the concurrence of Finance Department vide its U.O.No.3918/Health-II/2015, dated:02.02.2015 and ASL No.2381 (Two Thousand Three Hundred and Eighty One).
